**Caltrain Bicycle Locker Rental Agreement**

Thank you for your interest in renting a Caltrain station bike locker as a way to combine bike riding with train travel. Please check for locker availability at your preferred station at [www.caltrain.com/bikelockers](http://www.caltrain.com/bikelockers). Note: some station lockers are handled by other organizations. If a Caltrain locker is available, complete this application and return with a check or money order for \$91 (key deposit and rent for Twelve months). By signing the application, you agree to the Terms and Conditions below.

Caltrain will send one locker key to you along with a copy of this executed agreement

**Terms and Conditions**

- Renter must be at least 18 years old.
- Lockers are rented for a term of Twelve months at a rate of \$66 per term, plus an additional one-time \$25 key deposit. The rental rate may be changed by Caltrain at its sole discretion at the beginning of any Twelve-months billing cycle. Renter may terminate the Agreement at any time but will not receive reimbursement for rent already paid.
- Renter will be notified prior to the end of each term that payment is due for the subsequent Twelve-months term. If Caltrain does not receive full payment by the first day of each new term, it will assume that Renter does not wish to continue renting the locker and Caltrain may terminate the Rental Agreement. Upon notice of termination, Renter must return the key to the Caltrain Bike Locker Unit at the address located on the bottom of this form. Upon receipt of the key within the time specified in any Notice sent to Renter, Caltrain will mail a check to reimburse the deposit. If Caltrain does not receive the key within the time specified, the key deposit will be forfeited.
- Caltrain has the right to terminate this agreement for either cause or convenience. If Caltrain terminates for convenience, it will refund a pro-rata share of the unused rent, provided that Renter returns the key in the time specified by Caltrain. No rent will be reimbursed when terminated for cause or when the key is not returned in the time specified.
- Renter has 18 days from the date of termination, specified by Caltrain, to empty the locker. Any items that remain in the locker after 18 days will be disposed of in accordance with the law. Renter waives the right to require Caltrain to dispose of the property at public auction even if any property is valued at greater than \$700.
- All notifications will be mailed to the address provided on this form.
- The assigned locker shall be used only for the purpose of storing a bicycle. Caltrain has the right to inspect lockers at any time without notice.
- Caltrain and its contractor, Transit America Services, Inc., are not liable for any injury, loss, or damage arising from the use of any lockers.
- Failure to comply with the Terms and Conditions is cause for Caltrain to terminate Agreement, retain the key deposit and all remaining rent, and dispose of any property remaining in the locker in accordance with the law.
