Thank you for your interest in renting a Caltrain station bike locker as a way to combine bike riding with train travel. Please check for locker availability at your preferred station at www.caltrain.com/bikelockers. Note: Some station lockers are handled by other organizations. If a Caltrain locker is available, complete this application and return with a check or money order for \$58 (key deposit and rent for six months). By signing the application, you agree to the Terms and Conditions below.

Caltrain will send one locker key to you along with a copy of this executed agreement.

Terms and Conditions

- Lockers are rented in six-month increments. The initial cost includes a \$25 key deposit. Renter will be billed by mail for subsequent six-month rental periods. The current rental charge of \$33 for six months may be changed by Caltrain at its sole discretion at the beginning of any billing cycle. Customers will be notified via the information provided on this form.
- Full payment of rent is due by the by the 15th day of the first month of the rental period. Non-compliance will result in automatic termination of the lease. Rent due will be deducted from the key deposit, and any amount remaining will be forfeited if key is not returned to Caltrain within the first month of the billing period. Return keys to Caltrain Bike Locker Coordinator, 4000 Campbell Ave., Menlo Park, CA 94025.
- Renter must be at least 18 years old.
- Renter is responsible for notifying Caltrain of intent to terminate the lease. Renter has 15 days from such notice to empty the locker and return the key. Any unclaimed items left in locker after 15 days will be disposed of in accordance with the law. If the locker key is not returned within the 15-day notice period, the key deposit will be forfeited. Otherwise, a check for the key deposit will be mailed to customer. Unused rent from early termination will not be reimbursed.
- The assigned locker shall be used only for the purpose of storing a bicycle.
- Caltrain has the right to inspect lockers at any time without notice.
- Caltrain and its contractor, Transit America Services, Inc., are not liable for any injury, loss, or damage arising from the use of any assigned lockers.
- Caltrain shall have the right to terminate this agreement for its convenience. If Caltrain terminates for convenience, it will refund any unused rent. Renter has 15 days from such notice to empty the locker and return the key. Any unclaimed items left in locker after 15 days will be disposed of in accordance with the law. If the locker key is not returned within the 15-day notice period, the key deposit will be forfeited. Otherwise, a check for the key deposit will be mailed to customer.
- Failure to comply with the Terms and Conditions is cause for Caltrain to terminate Agreement, retain the key deposit and all remaining rent, and dispose of any property remaining in the locker in accordance with the law.
