**Subject:** Report of bumped cyclists

Dear Sir,

While participating in Bike to Work day (5/8/2014), I observed 2 cyclists being bumped from boarding Caltrain #319. The cyclists were denied access at the San Mateo station while trying to board a Bombardier coach.

I urge you to explore options to expand bicycle capacity on this coaches.

I think it would be a fairly straightforward effort to increase bicycle storage 2 times current capacity on the Bombardier coaches by simply installing racks above the current bicycle storage spaces. Most cyclists are familiar with the concept of hanging their bicycle from a wall or ceiling mount in their garage or home and the concept would apply equally well on Caltrain coaches.

This expanded capacity would require nothing more than mounting two 4 foot long cantilevered aluminum bars spaced approximately 24 to 30 inches apart 6 feet directly above current bicycle storage on effected Bombardier coaches. The cantilever would support a minimum load of 450lbs (30 lbs x 5 bicycles plus 200% margin of error). Cyclists would simply lift their bicycles up an onto the bars such that the bars would support the top tube of the front triangle of a typical double diamond frame thereby doubling bicycle storage capacity for a minimum cost.

Hi Andria.

Thank you for your reply, suggestions and looking into the situation. I definitely only have a the perspective of viewing from the outside so don't know the actual count of bikes on-board. All I can say is what I saw on one side of the train, empty and not full racks. It was Gallery equipment (80).

Though the suggestion of getting there early is great, it doesn't help if no riders are accepted on the train. Additionally, there is no "line" to get into. It is a free for all for riders. It is difficult to get other riders to accept the concept of a line when there is no one to regulate or provide instructions for lineup. I have tried. Sometimes an orderly line occurs, mostly it doesn't. If a train pulls up short of where a line has formed then those standing closest to the door are accepted on board, with out regard as to who is in a line. If a train pulls ahead of a formed line then it is a mad dash to the doors, often with the most pushy or insistent person getting on the train. Often times I've heard the same phrase yelled when someone suggests a line order be followed. That phrase is "I don't care, I NEED to get to work". Unfortunately the conductors aren't any help as they just accept the closest people to the door.

An orderly line would be a very welcomed addition. I would like to pose a counter suggestion to you. I propose CalTrain provide markers and a designated area at the train stops for bike riders to form a line. This would not only help riders self-organize. But it would provide a method for conductors to see and accept those riders in the line (and not who just so happens to be closest to the doors).


Again, thanks for providing this service and it's continued improvement.

Dear Mr. Doyle,

Thank you for submitting your comments to Caltrain. We apologize for the inconvenience and delay that you experienced on 4/15/14 and we regret to hear that you were unable to board your intended Train No. 324 that day. We have forwarded your report to the proper parties for review and we were informed that they interviewed the crew regarding this situation. On occasion the bicycle racks may get out of balance and the appearance of space is not necessarily the case as the total count cannot exceed 48 on Bombardier equipment and 80 on our Gallery equipment. We are considering alternatives to best meet the needs of all of our ridership. While there is room to board without a bicycle, one recommendation when traveling with a bike is to arrive early for the train so that you can be closer in line at the door when it's time to board. I take my bike on Caltrain every day commuting from 4th and King to Mountain View. I am lucky enough, at those two endpoints, that there is almost always enough capacity for bikes, for which I am grateful! I have been riding Caltrain since 1999 and overall the service is much improved over the last 15 years.

This morning unfortunately the 814 southbound was already full by 810 and it seems that there must be 15 or 20 bumps with me on the 819. As I am sure you are aware, all the benefits for me as a commuter of having express service are lost if I have to arrive at the station increasingly early just to be able to get on the train. I hope you will continue to look in to increased bike capacity on the additional equipment you are considering in the short term, and for electrification.


As an aside, you could substantially reduce dwell time for the gallery cars if you asked the conductors to direct foot passengers away from the northernmost car at mountain view. There is typically a delay of 20-30 seconds before the first bike can board, which would be eliminated if most pedestrians boarded at the next car. Of course I realize the delay is then compounded by "uncooperative" bike passengers who insist on stopping just inside the car to load their bikes --- I have no idea how to educate that kind of person to consider everyone's time above their fleeting convenience I'm afraid.

Thank you for your response and for confirming that the configuration of the new rail cars has not been determined. This leaves open the possibility of making the sixth car a bike car, something that would smooth operations and improve customer experience with more consistent service.

I agree that Caltain did a wonderful job of expanding onboard bike capacity in 2009 and 2011, and we thank you for that. Now it's 2014, and unfortunately every week many cyclists are bumped. Walk-on passengers are not bumped, but passengers with bicycles are.

There is a need for additional seating capacity on a few trains during peak commute period between the two busiest stops. But there is a need for more bike capacity before trains even leave San Francisco! We request that you consider this fact when you configure the new rail cars. Making the sixth car a bike car will allow more customers to bike to and from the stations, which will leave more room in parking lots for those who need to drive.

Regarding the date of my email, it's discouraging that my email took nearly two months to arrive. I emailed it three times, but it never appeared in the JPB correspondence packet, I didn't receive a reply from anyone at Caltrain, and I didn't receive an undeliverable message. Therefore, I contacted Josh Averill, and he kindly put me in touch with IT at Caltrain. After sending a series of test emails at IT's request, I learned that Caltrain's email client was rejecting emails with attachments, even small attachments. It makes me wonder how many other emails Caltrain did not receive. I hope this problem has been remedied.
