I am writing to ask that Caltrain <u>not</u> cut service or increase fares. To do those things will reduce ridership rather than encourage it. Public transport is MORE IMPORTANT THAN EVER as the climate catastrophe we face becomes ever more apparent. All those people in cars on 101 that drive in a parallel route to Caltrain's right of way? They are POTENTIAL RIDERS and must be encouraged to get out of their cars and get on the train. In order for this to occur, we have to make it easy and seamless — frequent service (ideally to the Salesforce station as soon as possible), easy regional connections all along the corridor, better service connections (as in the proposed passing station in RWC), clean seats and cars and stations (no leaky roofs please), etc. We can be the next Tokyo! Caltrain's <u>capital budget</u> for the coming year includes participation in major regional connections all along the corridor - the Downtown Extension to San Francisco Salesforce Terminal, a Redwood City passing station that will increase capacity and enable better schedule connections, fixing the leaky roof in the historic and Diridon station that is becoming a major hub. Also, safety fixes to ancient, at-risk bridges, and maintenance for system reliability. And, Caltrain plans to work with its train car manufacturer to explore possible hybrid trains for electric service to Gilroy.

Re: AB 1944 (Lee) - SUPPORT

Dear Assemblymember Lee:

On behalf of the Peninsula Corridor Joint Powers Board (Caltrain), I am pleased to support AB 1944, which would allow members of a local legislative body to vote to waive certain Brown Act requirements for meetings held partially or fully via teleconference.

Remote participation in official business by Caltrain Board Members has been critical for our system and communities during the COVID-19 pandemic. This bill would continue to allow this option for leaders of local bodies subject to the Brown Act.

Subject to a majority vote, this bill allows local legislative bodies to permit members to video or teleconference into a public meeting without needing to reveal their private address or participate from a public location. Members of the public would also be able to address their elected representatives through video or call-in options and ensure their voices are heard in local government decision-making during hybrid or fully remote meetings.

AB 1944 supports health and safety and increases options for community members to participate in local government meetings, while protecting the privacy of serving board members.
