# **ACTION**

Staff recommends the Board of Directors (Board) receive the attached informational presentation describing Caltrain's business outlook, near-term financial projections and potential areas of focus and priority for the coming fiscal year. No Board action is anticipated at this workshop. Based on Board input and discussion at this workshop, staff plans to return to the May Peninsula Corridor Joint Powers Board (JPB) meeting with preliminary Fiscal Year (FY) 2023 Operating and Capital budgets as well as a proposed FY 2023 work plan.

## **BUDGET IMPACT**

# **SIGNIFICANCE**

Starting in March of 2020 the emergence of the COVID-19 Pandemic resulted in a rapid and severe crisis for Caltrain, with ridership plummeting by as much as 98% and the implementation of significant service cuts. While the prolonged nature of the pandemic and the widespread adoption of remote work has continued to significantly impact Caltrain's ridership and fare revenue, the passage of Measure RR in 2020 and the receipt of significant Federal relief funding over the last two years has allowed the railroad to restore and sustain service.

As COVID-related health restrictions are lifted, Caltrain anticipates growth in ridership and increased activity on the system. At the same time, it has become increasingly clear that the future of commuting has changed and that remote and hybrid work will be significantly more prevalent than they were prior to the pandemic. As Federal relief funds are exhausted, this shift has profound near- and longer-term implications for the railroad's ridership recovery, finances, and overall business model.

Materials presented at the March 21 workshop will describe how Caltrain's business model has shifted and will present financial projections for the coming five-year period along with options and strategies to address anticipated financial shortfalls.

In addition to outlining the financial challenges the railroad faces, the workshop will also address key areas of organizational focus and will provide an opportunity for Board members to discuss their priorities and goals for the coming fiscal year.
