3. Staff Report

Casey Fromson, Chief Communications Officer, reported that Caltrain will have a 50% discount on almost all fares during the month of April. Ms. Fromson also reported that ridership is rising back up. Ms. Fromson talked about the March 10th collision on the Caltrain corridor, she thanked the Caltrain employees, emergency personnel, and transit partners for how they handled the immediate aftermath. She spoke on how the National Transportation Safety Board and other regulatory agencies are investigating the incident and that Caltrain cannot comment further as the investigation is still underway.

LPMG members' and alternate members' key comments and clarifications with staff included the following:

- A member asked for clarification on ridership being at 20%, staff confirmed that ridership is at 20%.
- A member commented that they believed the fare discount would be well received by the public and that they will make it well known throughout their community.

- A member asked for clarification on whether embankments were classified as grade separations, *staff clarified that it is based on individual circumstances*.
- A member asked that if grade separations need to be added if another environmental document would need to be done or if it could be incorporated into the pre-existing

- document, staff clarified that if the grade separations are in existing rail corridors that there are exemptions available for them.
- A member asked if there would be further details or broken out expenses that will be presented, staff said that the business plan for cost estimates in each project section.
- A member asked if any changes had been made since the letters from various jurisdictions or if they will be moving ahead with the current EIR as proposed, staff clarified that they are working to respond to every comment that they have received and adjusting where it is appropriate.

- MTC is putting together a package request for federal money for five to six grade separations along the corridor.
- There are concerns from the community that the process hasn't been as transparent as it could be.
- Improve lines of communication between all the cities and keep everyone up to date.
- To get projects to moved forward with funding, work with the corresponding transit agencies so that they are fully prepared and planned out.
- C/CAG and TA got together to see what projects are the most viable.
- Priority is being based on project readiness
- Need to come together as a corridor to figure out their own part
- Multiple cites have complaints about the current EIR that was presented and would like to see them resolved
