Good afternoon Mr. Birch. Your message to the Caltrain Board of Directors, Caltrain Citizens Advisory Committee and Bicycle Advisory Committee was referred to me for response. The groups will receive a copy of our correspondence.

We apologize for the inconvenience some cyclists experienced at the Palo Alto station yesterday. We have shared this report with our Operations staff to ensure that conductors communicate bike capacity to waiting cyclists, as well as allowing bike passengers on the platform to board when bike capacity permits.

Our conductors are responsible for only allowing a safe number of customers with bikes onboard the train, and we've determined that each rack can safely accommodate up to four bikes. We regret the challenge this policy causes to customers with bikes; however, our focus is on providing a safe service to all passengers.

Thank you for your feedback. We look forward to providing you with more positive experiences on your future commutes.

3 bikes were bumped from the 279 at Palo Alto this evening.

There was space, but the conductors just closed the doors, presumably because the train was running late and so many bikes were trying to get on. The north car was full and the conductor would only let 4 bikes on, the south car had a bunch of space and there was no conductor there so we could get on, but they closed the door forcing some riders off. More bikes got in the south car at Menlo Park.

On the older trains that have more space, strictly enforcing the 4-bikes per slot rule seems to insure against total overcrowding, but almost guarantee that riders will be kicked off during peak hour, or at stations immediately after busy stops. Can't this rule be revised to say, make sure each stack of bikes is behind the line on the floor? You can fit 6 or 7

kes/touring bikes with pannie	: 15.



SUBJECT: BUMP REPORT

Cyclists voluntarily report bumps (cyclists denied boarding due to insufficient bike capacity) to the Joint Powers Board (JPB), and these bump reports appear in the JPB correspondence packet. The BIKES ONboard team of the San Francisco Bicycle Coalition tallies the bump reports to create the graph below.



The graph represents a lower bound, because not all bumps are reported.

The table below shows the percentage change in reported bumps since March 2014, the last time I provided a bump graph to the BAC.

September 2014 sets a record high for reported bumps since we started tracking bumps in 2009. Bumps have increased dramatically over last year, showing that bike capacity is maxed out, which forces cyclists back into their cars, costing Caltrain ridership and revenue.

There are two things that can be done to help reduce bicycle bumps, thereby improving customer experience and encouraging more people to bike to and from Caltrain stations:

Short-term: Allow more than four bikes per rack by marking minimum aisle width.

Medium-term: Configure the new Bombardier cars as bike cars to increase bike capacity on

Bombardier trains to 72 bike spaces per train, close to the 80 bikes spaces

currently on gallery trains.

The new Bombardier cars are expected to be in service in fall 2015, but that is a year away, and Caltrain customers are faced with a serious shortage of bike capacity now. We encourage implementing the short-term solution as soon as possible to address the immediate need for more bike capacity, followed by the medium term solution to improve consistency in bike capacity across the fleet.

Good afternoon Mr. Tunnacliffe. Your message to the Caltrain Board of Directors, Caltrain Citizens Advisory Committee and Bicycle Advisory Committee was referred to me for response. The groups will receive a copy of our correspondence.

We apologize for the inconvenience experienced on Train 324 and regret any unclear communication provided by the conductor during the boarding process. We have shared this report with our Operations staff to ensure that conductors communicate bike capacity, policies, and bike car location in a clear and professional manner.

While we try to accommodate as many bicycles as possible, the total count cannot exceed four per rack for a total of 48 on Bombardier equipment and 80 on our Gallery equipment. If the bike car is full, customers will have to wait for the next train with bicycle capacity as our conductors are responsible for only allowing a safe number of customers with bikes board the train.

Again, we apologize for the inconvenience you experienced on your first commute with your bicycle. We look forward to providing you with more positive experiences on your future commutes.
