## **Bike Share Program Station Data**

- The Bike Share data shows that stations located at Caltrain stations are generally the most popular origin stations. In Mountain View 47% of trips begin at the Caltrain stations, which make up only 29% of the bikeshare stations in Mountain View. In Redwood City, 47% of trips start at the Caltrain bikeshare station, while in San Jose, 23% of trips start at the Caltrain station, which only makes up 6% of the stations in San Jose. In SF, 8% of trips start at the 4<sup>th</sup>/King station, 40% more trips than the next busiest station at the Ferry Building.
- The story is similar on destination stations within each service area (with the exception of the University and Emerson Bike Share station in Palo Alto, which ranks above the Palo Alto Caltrain station as the most popular destination Bike Share station).
- In the case of Palo Alto and Mountain View where two Caltrain stations are served by Bike Share, the Palo Alto and Mountain View Caltrain stations are more popular in terms of Bike Share origins and destinations than the California Avenue and San Antonio Caltrain stations.
- We know that Bike Share is primarily used by Caltrain commuters, many of whom arrive from San Francisco. Bike Share use also typically peaks during the morning and evening hours, indicating the prevalence of commute trips.
- We are completing a survey of Bike Share annual members to confirm whether Caltrain riders were more inclined to leave their personal bikes at home because of Bike Share access.
- The Bike Share stations located at Caltrain stations are generally the most popular in terms of origins and destinations within each service area, indicating high use by Caltrain commuters.
