





## **DIRIDON STATION PARKING STALL CLOSURE NOTICE** | May, 2020

#### **UPCOMING ACTIVITIES AND CLOSURE**

Beginning **May 25**, Caltrain Electrification crews will temporarily close seven (7) parking spaces in the southeast portion of the Diridon Station parking lot in order to perform trenching work to support the Caltrain Electrification project.

The construction area of the southeast portion of the Diridon Station parking lot will be temporarily closed and fenced off in order to support this construction. The temporary parking closures will last from **May 25 until June 11, 2020.** 

While the construction area will be closed to the public 24/7, pedestrians will still be able to access the station platform from the southeast portion of the parking lot.

A map of the temporary closure area is provided on the back of this notice.

#### CONSTRUCTION ACTIVITES

The anticipated construction activities during this time will be for the removal of existing asphalt, and concrete. Work will consist of demolition, excavation, and removal. Crews will utilize excavation equipment, pneumatic hammers, and dump trucks for removal.

Work will take place during the day and at night, with work occurring between 7 a.m. and 3:30 p.m. Monday - Friday. The construction area will be closed to the public 24/7 during the construction period.

#### **PROJECT OVERVIEW**

Over the last decade, Caltrain has experienced a substantial increase in ridership and anticipates further increases in ridership demand as the Bay Area's population grows. Caltrain Electrification, scheduled to be operational by 2022, will electrify and upgrade the performance, operating efficiency, capacity, safety and reliability of Caltrain's commuter rail service.

Caltrain Electrification is a key component of the Caltrain Modernization Program and consists of replacing diesel-hauled with an electric train system for services between Fourth and King Street Station in San Francisco and the Tamien Station in San Jose. The project will include the installation of new electrical infrastructure and the purchase of electric trains.




