## MILLBRAE STATION PARKING STALL CLOSURE NOTICE | September, 2021

### UPCOMING ACTIVITIES AND CLOSURE

Beginning as soon as **September 15**, Caltrain Electrification crews will temporarily close eighteen (18) and permanently close three (3) parking spaces of the Millbrae Station parking lot off of California Drive near the train museum, in order to perform signal house work and installation to support the Caltrain Electrification project. The temporary parking closures of **spaces 2-19** will last from approximately **September 15 until October 31, 2021. Spaces 20-22 will be permanently closed in order to facilitate the new signal house. No Parking notices will be placed in front of the closed stalls no later than 24 hours before the closure.**

A map of the temporary closure area is provided on the back of this notice.

### CONSTRUCTION ACTIVITIES

The anticipated construction activities during this time will be excavation, shoring, conduit installation, pre-cast electrical pull box installation, and backfill duct bank. The parking spaces will be used for staging equipment and materials. Crews will utilize excavation equipment, pneumatic hammers, and dump trucks for removal.

Work will take place during the day and at night, with work occurring between 7 a.m. and 3:30 p.m. Monday - Friday. The

parking spaces will be closed to the public 24/7 during the construction period.

### PROJECT OVERVIEW

Over the last decade, Caltrain has experienced a substantial increase in ridership and anticipates further increases in ridership demand as the Bay Area's population grows. Caltrain Electrification, scheduled to be operational by 2024, will electrify and upgrade the performance, operating efficiency, capacity, safety and reliability of Caltrain's commuter rail service.

Caltrain Electrification is a key component of the Caltrain Modernization Program and consists of replacing diesel-hauled with an electric train system for services between Fourth and King Street Station in San Francisco and the Tamien Station in San Jose. The project will include the installation of new electrical infrastructure and the purchase of electric trains.

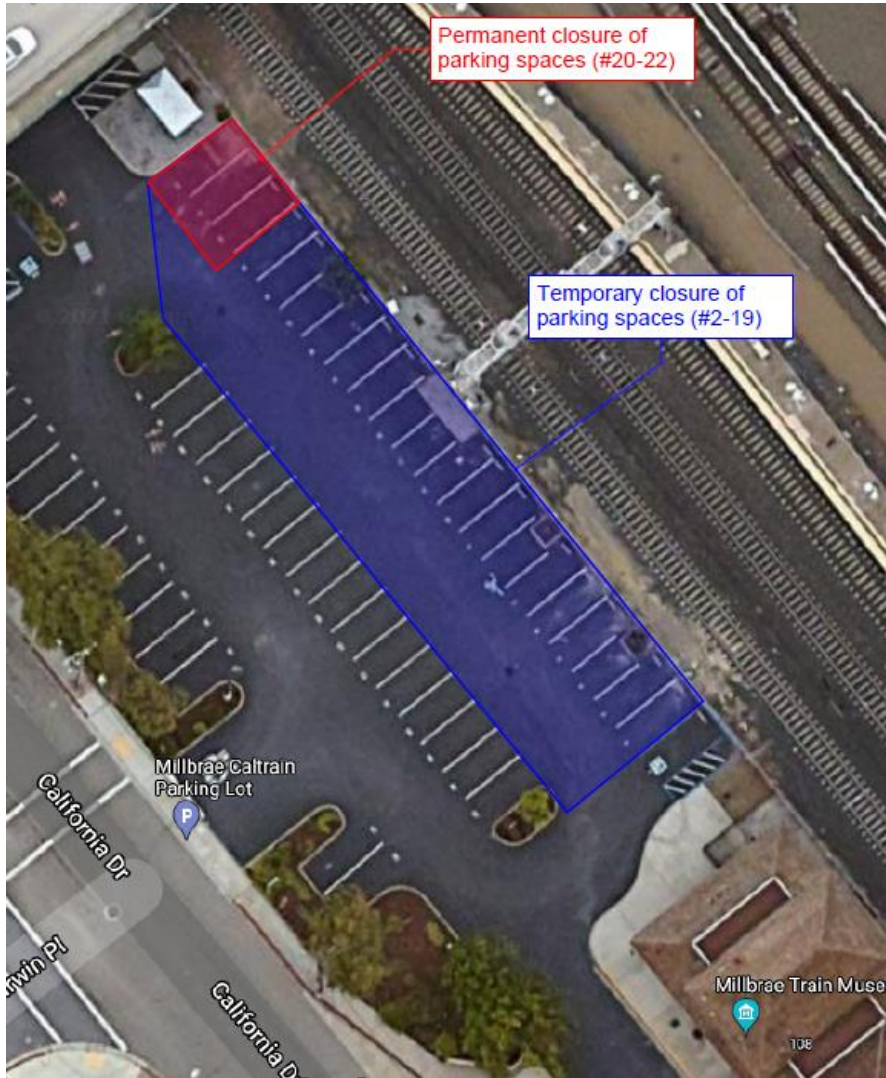
