<u>JOB SUMMARY</u>: The Manager, Utilities reports to the Manager, Construction Services and is responsible for coordinating and facilitating utilities relocation, protection and abandonment or any other modification to utilities during the course of Caltrain construction activities

### **EXAMPLES OF ESSENTIAL FUNCTIONS:**

- Manage the utilities matrix with utility owners, with particular emphasis on conflicts, to confirm utility owner's relocation plans, cost sharing, rights, and schedule.
- Requires management of local utilities improvements, new construction, relocation, and disconnection. (Including filing the required applications for new service).
- Responsible for reviewing utility plans with the Caltrain Right-of-Way management and the Caltrain Engineering Department and making recommendations accordingly.
- Oversee field investigations such as geotechnical, utility potholing, surveying, etc. as required.
- Develop relationships and build consensus for coordination and actions, with and by utility companies.

## EXAMPLE OF DUTIES:

- Receive utility support plans, exhibits and documentation for utilities relocation work from project designers including but not limited to staging, phasing, traffic handling and traffic control.
- Check and update project utilities matrices with the project manager project designer.
- Review plans for protecting above and below ground utilities in the area of the work.
- Manage contractors on temporary utility connections including water, sewer, power, etc.
- Support the Project Manager with budgets and schedule preparation.
- Oversight with Construction Management team on execution of utility relocation work.
- Review contractor specifications and plans for utility relocation, ensuring safety and protection.

**<u>SUPERVISION</u>**: Works under the general supervision of the Manager, Construction Services who establishes goals and objectives and evaluates performance.

**<u>MINIMUM QUALIFICATIONS</u>**: Sufficient experience, training and/or education to demonstrate the knowledge and ability to successfully perform the essential functions of the position. In lieu of a degree, work-related experience that demonstrates the skills and experience necessary to perform this role will be accepted. Development of the required knowledge and abilities is typically obtained through but not limited to:

- Bachelor's degree in engineering or related field.
- Five (5) years full-time professional experience in project management that includes utility relocation, and /or Civil or Transportation Engineering
