


Requested Board Actions

- 2. Authorize an increase of the contract contingency from 10% to 30% of the Board awarded total amount of \$2,066,880 (from the contingency amount of **\$206,688 to \$620,064**) for the Bayshore Station Painting Project (Project) under Contract No. 20-J-C-079 with Top Line Engineers, Inc. of Hayward, California (Top Line).
- **3.** Authorize the Executive Director or designee to execute a contract in a form approved by legal counsel, and to take **any other actions necessary** to give effect to the agreement.








Bayshore Station – Pedestrian Bridge

Project Scope

- Construct Containment System
 - Protect trains, trackway, and passengers from noise, dust, and debris
- Remove and replace coating system on all steel surfaces and wire mesh panels, and repair corroded steel areas
 - Base Contract Pedestrian Bridge Complete
 - Option Bid Stairwells Current Work
 - Option Bid Elevator Towers Current Work



Stairwells and Towers Work

- To complete painting operations at east and west towers the stairwells must be closed
- Duration of closure estimated to be **90 days**
- Southbound platform only accessible through the towers
- To maintain passenger access, a shuttle service between platforms is proposed
 - Allows work to be completed expeditiously
 - No impact to train operations
 - Enhance safety by physically separating work and passengers
 - Mitigate risk to overhead contact system construction delays

Compass Transportation

- Proposal were sought from multiple transportation providers
- Only **Compass** was able to meet Caltrain's shuttle service requirements
- Compass has sufficient **experienced drivers** and fuel-efficient shuttles
- Analysis of Compass' \$475,000 price proposal determined to be fair and reasonable
- Sufficient project funds available for requested shuttle services contract
