BART TO SILICON VALLEY

Adriano Rothschild, Grant Brokl, and Erica Roecks, Santa Clara Valley Transit Authority's (VTA) External Affairs team provided a presentation that included the following:

MTC REGIONAL BIKESHARE LETTER

Vice Chair Bargar reported the MTC (Metropolitan Transportation Commission) is actively engaged in planning for both Plan Bay Area 2050 effort and possible coordination of 2026 regional funding measure. This letter is to encourage MTC to pursue and take an active role in regional bike share systems.

Signs on front of train had inaccurate information about the available number of bike cars causing confusion. Member Rodia stated seeing the same.
