

Project Background

VTA's BART Silicon Valley Phase II Extension (Phase II Project) is a six-mile, four-station extension of BART from Berryessa / North San José Station (opened 2020) through downtown San José to the City of Santa Clara. The Phase II Project is planned to include an approx. five-mile subway, three stations with underground platforms (28th Street/ Little Portugal, Downtown San José, and Diridon), one ground-level station (Santa Clara), a train maintenance and storage facility, and additional facilities.


See the Results of Long-Range Planning with VTP 2050 Community Field Trip


- Milpitas Transit Center is served by VTA routes 20, 44, 47, 60, 70, 71, and 77, as well as the VTA Light Rail orange line.

At the October 5th Peninsula Corridor Joint Powers (Caltrain) meeting, the Board of Directors adjourned in the memory and honor of the late Senator Dianne Feinstein.

Senator Feinstein was a memorable woman who was loved and appreciated by all for what she brought to California, Senator Dianne Feinstein was a stalwart champion of rail safety in California and throughout the nation. After the Chatsworth disaster in Southern California, Senator Feinstein spearheaded legislation that led to the nationwide adoption of positive train control safety technology which prevents train-to-train collisions, over-speed derailments, and other dangers. This technology is now fully operational on Caltrain's corridor, further protecting our riders and communities.

Moreover, Senator Feinstein was an ardent supporter of Caltrain's Electrification Project, working to ensure full funding for the project including securing \$10 million in dedicated federal funds just last year. The Senator also supported the effort to reimagine Caltrain's San Jose Diridon Station, transforming it into a cutting-edge multimodal hub befitting of one of America's largest cities.

Her impact on American railroads and specifically the impact on the first electric commuter rail in the American West will be felt for generations.

Dear Board of Directors of Caltrain,

I am writing to bring to your attention a deeply distressing incident we experienced on September 21, 2023, aboard the L3 #313 Northbound train, which stopped at Palo Alto at 6:54 PM. As a regular and loyal Caltrain rider, I never anticipated facing such a situation on one of your trains.

Yesterday evening, my partner visited me at work from SF and tagged on her clipper card at the San Francisco 4th and King Street Caltrain station. She is not a regular Caltrain rider and forgot to tag off at the Palo Alto Caltrain station immediately upon disembarking. Later, when we returned to the Palo Alto Caltrain station, she first tagged off on the Southbound platform for the previous ride and then tagged on again on the Northbound platform for our return journey. However, there was an error with the tagging machine on the Northbound platform she used, and when checked by the onboard conductors, her card showed it was not tagged on, despite having a sufficient balance.

Both of us were confronted and threatened by conductors Kathleen and Michael, who insisted that we disembark the train. Kathleen not only threatened to call the police on us but, after we complied and disembarked, she waved goodbye and took off, leaving us stranded in the cold at Belmont station, waiting for the next Caltrain. Due to this prolonged exposure to the cold, my partner fell ill last night. This aggressive and discriminatory behavior is deeply concerning and suggests a potential lapse in the training or oversight of Caltrain staff. I can provide evidence to confirm that I had a valid train ticket and that I was unjustly forced off the train due to the inappropriate actions of your employees.

I urge the Board to treat this matter with the seriousness it deserves and to ensure that such incidents do not recur. Passengers should feel safe and respected when using Caltrain services, and the behavior we experienced is a stark deviation from the standards one would expect from a reputable transportation service.

I look forward to your prompt attention to this matter and hope for a thorough investigation and appropriate action.



Hi Chief Mata,

I am a homeowner at Station 121 townhomes living opposite the giant encampment on Great Oaks Pkwy. We see a lot of criminal activities after the surge in tents in early June. We have 22+ tents now. Our location map is below. I am trying my best to explain the gravity of the situation. The tents are spread across a 0.5 mile length on Great Oaks side by the Blossom Hill Caltrain fence (ripped by the homeless in many areas). I have circled the high-density apartments and townhomes. Our townhome community has 143 homes, apartment Lex has 387 units and Oak Grove has 134 units. Even if you assume there is an average of 3 people in a unit, you are looking at 2000 people affected by this encampment. Ramac Park is our breathing space in this area.



We have seen the following issues

- repeated gang tags
- crazy, drugged-up homeless people terrorizing the area
- frequent mail thefts
- homeless people casing our homes
- ransacking porches
- urinating on a neighbor's porch, community playground area, in the mailboxes
- trespassing into the patio and sleeping on the furniture.
- sleeping on the bench in the children's playground
- constant trespassing
- loud music

- frequent fire incidents though instructed by the city not to light fires because of the dry vegetation and the trees hovering over the tents.

- Ripping fences near the Caltrain station
- repeating illegal crossing of the tracks
- lighting fire pits, having propane tanks
- having projector etc (not sure where they get power from)

- harassing women boarding the early morning train. It is dark outside. Homeless people sleep on the ramp and once grabbed hold of a woman's leg when she was trying to go through the ramp. She is now driving to work in San Mateo (does not feel safe in the station anymore) - when you look at crime mapping, there are so many shoplifting incidents in the retail stores nearby. This area was designed to be an urban transit village with access to public transit, stores, restaurants, etc.

- We see so many carts strewn across the area by the homeless blocking sidewalks and even the bike lanes.

- There have been incidents of disturbance in In-n-Out. There was a really intoxicated person yelling and threatening people there. He quickly ran to Ramac Park and to the Great Oaks area. The police could not get hold of him. I think the police were cautious about not hurting him or something.

- There have been multiple incidents of narcotics /alcohol incidents as per the crime map


- Some of these people have cars or have buddies who have cars. They park the car by the right lane (blocking one lane of traffic). They illegally park the cars by the tents. There are only two lanes and a bike lane. No curbside parking

- We have witnessed violent fistfights on the road bringing traffic to a standstill - One person even managed to enter one of the townhomes and went to a neighbor's bedroom(3rd floor) at 5 a.m. It freaked out the young family. He left soon without any other incident after being yelled at. It would have been a different outcome if the homeowner was armed or something.

- As Mila and Elvera have sent information multiple times, there is a link to the people in the encampment and the stolen cars and car stripping in the Caltrain parking spot across the tracks.

We in San Jose have reached a station where law-abiding taxpayers feel helpless because the concerns we raise fall on deaf ears. Criminals are bold because almost every illegal activity they do does not have any consequence. Everyone knows that this encampment thrives on package thefts (around 650 residential units in a 0.5-mile radius) and shoplifting (Target, Safeway, Marshalls, Ulta, etc.). That is why this area is such a magnet for the homeless. We have had a few tents in the past. They got abated after some time. But in spite of our repeated requests, BeautifySJ never did any deterrent here to prevent tents from coming. This is just a disaster in the making. There are so many tents in the Endicott-Great Oaks Pkwy corner as it is so close to the shops. It is a no-brainer! The city should not be enabling this behavior by helping them stay here indefinitely and SJPD should not be turning a blind eye towards this issue.

Criminal activity was a trigger for abatement. We have been trying to work with BeautifySJ for so long and they believe that providing free trash fixes everything (which they don't do enough anyway). The cash for trash encourages these folks to hoard more and pile more litter. Andrea Flores Shelton (Deputy Director BeautifySJ) told me that they may be able to do something if SJPD can report criminal activity due to the encampment. I request you to take a look at this situation and do what is in your capacity to help us solve this issue. All we are asking is a safe neighborhood for our children. SJPD could play a major role in helping us move towards an abatement.



Adding Caltrain board also - they should be responsible for taking care of their passenger safety and making sure that their tracks are safe from people running across.

Good morning, Izzac,

I'm not going to say, "No," to you meeting with our Gang Investigations Unit, but it is completely unnecessary. I am aware of all the tagging, what it looks like, what it means, and where it is. I'm also watching our gang crime to determine if we have any spikes. I attend the San Jose Youth Empowerment Alliance (formerly the Mayor's Gang Prevention Task Force) meetings every month, and I'm a team lead. I also manage three walking beats and one suppression detail where I can provide targeted enforcement to problem areas.

Ultimately, I have a handle on this.

Norteno graffiti is not unusual in the area. We have several gangs in Southern Division and we're constantly keeping an eye on them. Typically, the prevalence of tagging will ebb and flow. Right now,

it's ebbing. We're seeing more graffiti, but not the respective surge in gang crime.

There is Nortenos tag and they were going right on the spot it was marked. They have stuff by the trees next to the road at Xanders near Lowe's at Cottle and I think we saw in this one too.

I suspect they are marking some spots for something with the tags or a place to go. The woman had a bottle like liquor on her backpack.

The Caltrain lot car has a notice. And the white SUV at Beswick where the security guy was has a notice too.

Joseph Rois shared with me the audit for parking compliance and they mentioned that they hire contractors to do parking compliance too. It was probably a city contractor. Not sure if they were doing before or started to do now. The report is from 2021 I think.
