#### Scope of Work RFP#24-J-P-016 On-Call Alternate Project Delivery Support

- Provide Independent Cost Estimate for Construction Phase Work
- Support Agency with its Total Contract Price (TCP) review and negotiation with the Contractor
- Provide collaboration support to develop the Project Risk Register and develop the Risk Allocation and Mitigation Plan including risk-based cost assessment
- Provide support in Contractor incentives for the following possible criteria: Safety,
   Quality, Community Relations, Diversity, Cost Control, Schedule Control, and Sustainability
- Review, comment, and validate the Contractor's Construction Phase Work planning



#### Procurement Background

- On **August 29, 2023**, the JPB issued an RFP, solicitation number **24-J-P-016**, for the Services and advertised it on the JPB procurement website. Staff held a pre-proposal video conference and two (2) potential Proposers attended.
- On **September 25, 2023**, the following two firms submitted Proposals:
  - 1. Dynamic Preconstruction Services, Carlsbad, CA
  - 2. Kelly McNutt Consulting LLC, Vancouver, WA
- After the initial scoring of the technical proposals and interviews with both firms, the Committee determined Kelly
  McNutt Consulting LLC to be the highest-ranked firm with the most qualified Proposal and approach for the OnCall Services

- The **Rengstorff Grade Separation** project was approved by the Board in FY19 for a budget of \$3,500,000 funded by the City of Mountain View. In FY23, the Board approved an additional budget of \$18,500,000, funded by Santa Clara Valley Transportation Authority (VTA) Measure B, increasing the project's budget to **\$22,000,000**.

#### Staff Recommendations

- Award an on-call contract to Kelly McNutt Consulting, LLC of Vancouver, WA (Kelly McNutt) to provide the Services for a total not-to-exceed amount of \$2.5 million for a five-year base term.
- 2. Authorize the Executive Director or designee to execute a contract with Kelly McNutt in full conformity with the terms and conditions of the solicitation documents and negotiated agreement, and in a form approved by legal counsel.
- 3. Authorize the Executive Director or designee to exercise up to two one-year option terms with Kelly McNutt, for a total not-to-exceed additional amount of \$1 million, if deemed in the best interest of the JPB.
