5. TA Board Item 10.a. San Mateo County Shuttle Program Update and Call for Projects Fiscal Years 2026 and 2027 Draft Recommendations

Sue Ellen Atkinson, Manager, Planning and Fund Management, and Julien Jest, Manager, Market Research and Development, provided the presentation that included the following:

- Funding rollover from decreased ridership
- Increasing costs for funding ridership from pre-pandemic amount of \$10- stabilization of operating cost but reduced service
- Data captured by 2024 Shuttle Survey
 - Demographics
 - Rider habits- decrease in average ridership to two to three days per week; shuttle connectivity with other modes of traffic
 - Rider satisfaction measured by overall quality, driver courtesy (highest score), cleanliness of shuttle, reliability of service, and on-time performance (lowest score)
- Opting to drive alone or use of ride share company in the presence of no shuttles
- Amount available of \$16 million from TA Measure A Local Shuttle Program Funding and \$1 million from City/County Association of Governments of San Mateo (C/CAG) Congestion Relief Plan
- Provision of commuter shuttles and community shuttles
- Call For Projects (CFP) evaluation kicked off on January 13, 2025, resulting in 23 applications from five sponsors (19 commuter shuttles and four community shuttles)
- Reduced shuttle routes requests due to increasing costs, elimination of shuttles, and decrease in ridership

- Opportunity for community colleges to receive service
- Evaluation criteria categories consisting of Equity, First/Last Mile Need, Maximize Ridership, and Bonus
- Support for funding for 23 requested shuttles
- Program accounting for significantly higher costs, fixed Measure A funds (four percent), terms of commitments/contracts (10-year contract, with two-year funding commitment)

The Committee members had a robust discussion and staff provided further clarification in response to the Committee comments and questions, which included the following:

- Unavailability of shuttles- about 65 percent of commuters would use another method other than driving
- High costs per person but reduction of Vehicle Miles Traveled (VMT), providing an option for service (free service with increased costs)

Subject:	Report of the Chair

There are many transportation challenges that the San Mateo County Transportation Authority and other Bay Area transit agencies face in order to operate efficiently. But in the 18 years that I have been a member of the Transportation Authority's Community Advisory Committee (CAC), the last 15 of which being the Chair of same, I have concluded that the infusion of a steady stream of funding for any and all projects is of the utmost importance, and the more financial support that you can get for a project, the better the chances are that it will have a successful completion.

Money is the "bottom line." Money is the deciding factor in what projects go forward and what projects do not. Without a sustainable source of funding, budget challenges will force transportation agencies across the Bay Area to make major cuts in both projects and services.

Currently, the passage of a Regional Measure authorized by Senate Bill (SB) 63 is crucial for the future of transportation funding in the Bay Area, particularly for San Mateo, San Francisco, Alameda, Contra Costa and Santa Clara Counties, due to the potential for a dedicated funding source of major transit systems such as Caltrain.

Here's why it's so important:

- 1. Addresses a Dire Funding Need:
 - Major transit agencies like BART, SF Muni, Caltrain and AC Transit faces significant operating deficits of over \$700 million by 2026, potentially leading to drastic service cuts without new funding being supplied.
 - SB 63 provides a mechanism (a sales tax) to generate most needed revenue to sustain and improve these critical transit systems.
- 2. Enables a Regional Funding Solution:
 - The bill allows for a regional tax measure to be placed on the 2026 ballot, creating a dedicated and reliable funding sources for transit.
 - It encourages a collaborative approach requiring counties and transit operators to work together on a spending plan to allocate funds effectively.

- 3. Promote Financial Efficiency and Coordination:
 - SB63 mandates financial efficiency revenues for transit agencies receiving funding potentially leading to cost saving measures.
 - It requires agencies to comply with regional coordination, policies promoting better integrated and a more seamless transit experience for riders.
- 4. Provides an Opportunity for Voter Approval:
 - The bill allows for the tax measures to be placed on the ballot, giving voters the opportunity to decide whether to invest in the future of public transit.
 - A tax measure placed on the ballot through a citizen's initiative would only require a simple majority to pass, raising the likelihood of success.

Specific Importance for the Three Counties:

- San Francisco: Muni faces a significant funding gap and SB63 offers a potential solution through a dedicated sales tax.
- San Mateo and Santa Clara Counties:
 - These counties can opt into the Regional Measure, potentially benefiting from the funding to support services like Caltrain, which is facing its own financial challenges.
 - The Legislature has given both San Mateo and Santa Clara Counties until July 31, 2025, to opt in.
 - City Councils are presently holding City Council meetings to decide whether to support this new Regional Measure.
