






<u>Safety Updates – Injuries and Accidents</u>


Reportable Injury Trends



Reportable Injury Rates (RIR) are based on the number of railroad worker on duty injuries and illnesses per 200,000 employee-hours annually (equivalent of 100 full time employees). The national average RIR is 3.0 across all industries, per the U.S. Bureau of Labor Statistics. Caltrain's cumulative RIR for calendar year 2025 is 1.01.

Strains or sprains constitute the majority (55%) of reportable injuries for Caltrain's operators.

Reportable Rail Equipment Incidents



Reportable railroad accidents/incidents are divided into three groups: (1) Highway-Rail Grade Crossing; (2) Rail Equipment; (3) Death, Injury and Occupational Illness.

Reportable Rail Equipment Incidents from recent years peaked at 6 in 2024. There were no reportable incidents in 2023, and there have been no reportable incidents thus far in 2025.

Safety Culture Engagement Efforts

Ongoing Safety Culture Transformation

- Safety Champions continue to help create safety messaging, encourage safety concern reporting, model safe behaviors, and obtain feedback from peers. Safety Champions are moving forward with high impact projects to advance a strong culture of Safety.
- Chief Safety Officer issues regular correspondence to Caltrain employees about the importance of continuing to put Safety First and Always. Recent messages covered topics such as learning culture and safety moments.
- Caltrain continues a "Safety Leaders of the Quarter" recognition program to acknowledge and celebrate employees who are actively contributing to a positive safety culture. A new group of Safety Leaders (the fifth cohort thus far) was recognized in July 2025. Next Safety Leaders to be recognized in the upcoming All Hands Meeting.
- Caltrain staff significantly expanded the Rail Safety section of the agency's intranet including links to key resources such as the hazard reporting log.

Recent Engagement Activities

- Working with implementing ComplianceQuest for event reporting, hazard reporting, corrective action tracking, etc., Phase 1 user acceptance testing has started, and Phase 2 will begin soon.
- Brought in-house monitoring of leased camera towers via the District's SOC. Fifteen camera towers are deployed from San Francisco 4th/King to San Jose Almaden Road. Power Control Supervisors and CCF are given accounts to have limited control and viewing of the camera towers; access has now been secured for live viewing, and they continue to be able to request and view recorded footage. Any suspicious activities detected by SOC are communicated to CCF, who then determines escalation; the

towers have been able to capture footage of various events such as thefts, trespassing on the right-of-way, and damage to a gate crossing due to a vehicle, with re-deployment scheduled for an additional location to deter trespassing/ encampments.



















Safety Culture Engagement Efforts (cont'd)

- Part of a working group internally and with regional transit agency partners to discuss and help plan for 2026 Superbowl and FIFA events.
- Part of working group related to unhoused persons at SFO and how they may impact nearby transit services.
- Exploring mass notification communications tools such as ReadyOp for District use during major emergencies.
- Submitting CPUC GO-88 applications to modify high risk grade crossings with solar markers and bollards. Installation at Broadway has already yielded a 100% elimination of track incursions.
- Met with technology companies to discuss GPS navigation safety enhancements for grade crossing areas. Notably, Google introduced an update that now verbally alerts map users when they approach a railroad crossing.
- Launched the internal "Why is Safety Important to Me?" campaign, encouraging employees to share a photo and story that highlights the importance of "Going Home Safely, Every Day." The campaign is featured on digital displays throughout administrative and operations offices.
- Electric train environment communication
- Safety Roadshows are ongoing May 28 at CEMOF Maintenance Facility, Jun 25 at Menlo Park, July 30 at SFK 4th & King, and most recently Aug 27 at CEMOF.
- Conducted a full-scale exercise at Redwood Junction on 8/16/25, with Redwood City FD, Menlo Park FD, Woodside FD, CERT volunteers, Transit PD and TASI. Simulated an on-board train fire and a high voltage step potential hazard outside the train (wire down).




















Percentage of trains arriving within six minutes of the scheduled time

Average Daily Ridership


Average estimated weekday ridership

Ratio of fare revenue to operating costs



Average miles travelled by locomotives before maintenance/repair is required








Trains are considered on-time if they arrive within six minutes of the scheduled arrival time at end-line locations (i.e. San Francisco, San Jose Diridon, Tamien, and Gilroy).

The on-time performance (OTP) goal for Caltrain is 95%. Combined OTP for the month of July was 95.3%; this resumes our achievement of the 95.0% goal after a gap since November 2021, primarily due to JPB Capital Projects.

Monthly On-Time Performance in the Past Year





















Reasons for Train Delays, by Minutes of Delay






















Since November 2023, Caltrain's ridership estimation model relies solely on fare media sales data.





Special Service Ridership Report

San Francisco Station

- Total event-day ridership at San Francisco Station in July was 135,055, a 113.6% increase compared to 2024 (63,224) and a 41.1% increase from 2019 (95,708).
 - In July 2025, there were 19 events (13 Giants regular season games, 2 Valkyries regular season games, Post Malone, My Chemical Romance, and Lady Gaga concerts, 4th of July Fireworks) compared to 12 in 2024 and 11 in 2019.

Mountain View Station

- Total event-day ridership at Mountain View Station in July was 4,725, a 14.5% increase compared to 2024 (4,126), and a 435.7% increase from 2019 (882).
 - In July 2025 there were 3 events (2 The Weeknd concerts, and the Gold Cup semi-final), compared to 4 in 2024, and 1 in 2019.




















Public Transit Ridership Recovery in the Bay Area




Total Fare Revenues (\$M) - Past 3 Months Comparison

Fare revenue is generally more stable than ridership due to many riders paying for monthly passes, which provide consistent revenue regardless of usage.










Parking Revenue is generated by purchases of daily and monthly parking permits for parking at Caltrain-owned lots.
























Maintenance Performance (Diesel Fleet)







Equipment Availability is the number of trainsets, locomotives, or cars available for service on an average day each month as a percentage of the daily equipment required to run base service.



10. Receive Update on Capital Project Cost Growth

Chair Heminger and Ms. Bouchard introduced Peter Rogoff, The Contorta Group, who provided the presentation that included the following:

- Influences on construction pricing; reviewed factors under JPB's control
- Worldwide increasing cost challenges impact all major infrastructure areas
- Supply chain challenges impact 55 percent of industry; rising pricing; tariffs uncertainty keep prices high and volatile
- Transit projects with specialized components and long lead times for procurement
- Skilled labor and retaining skilled labor shortage across all crafts and disciplines
- American Recovery and Reinvestment Act of 2009, Infrastructure Investment and Jobs Act (IIJA), and Creating Helpful Incentives to Produce Semiconductors and Science Act of 2022 (CHIPS and Science Act) federal funding projects nationwide
- Artificial Intelligence (AI) companies pay premium for data centers drawing contractors
- Interest rates remain high; reduced competition in marketplace; public works projects receiving less bids
- Contractors avoiding uncertainty: favoring projects that have less complexity, less uncertainty, and less risk or shared risk with project owner; clear path to profitability for contractors
- Best practices to contain costs included:
 - Bringing contractors in earlier to learn all details of project and eliminate unknowns
 - Contractor stipends to keep competitors interested in projects
 - Bundle contracts and sequency work to bring in more bidders

Purpose and Recommended Action

Staff recommends that the Board of Directors (Board) of the Peninsula Corridor Joint Powers Board (JPB or Caltrain) award the proposed Master Service Agreement (MSA) to Wabtec Transportation System, LLC of Pittsburgh, Pennsylvania (Wabtec) to provide maintenance and support services and additional as-needed services (collectively "Services") to ensure continued maintenance and operational availability of Caltrain's Train Control System, which is currently provided by Wabtec. This contract is critical to maintaining compliance, increasing efficiency and sustaining operational tempo. Failure to retain support and enhance these core operational systems could be detrimental to regulatory requirements, revenue operations, and customer experience.

Staff proposes that the Finance Committee recommend that the Board:

- Award a sole source MSA to Wabtec for the provision of the Services for a total not-to-exceed of \$3,982,553, which includes \$2,872,553 for annual maintenance and support fees and \$1,110,000 for additional as-needed services for Rail Operations Control System (ROCS), Supervisory Control and Data Acquisition (SCADA) System, and Predictive Arrival and Departure System (PADS) (Systems) for a five-year term.
- Authorize the Executive Director or designee to execute an MSA with Wabtec in full conformity with the terms and conditions of the negotiated agreement, and in a form approved by legal counsel.

Discussion

Pursuant to Resolution No. 2019-30, the JPB entered into a sole source agreement with ARINC, Inc. of Annapolis, Maryland (ARINC) to provide the Services for ROCS and PADS under Contract No. 19-J-T-110. ARINC's Surface Transportation business was acquired by Wabtec, effective on June 9, 2022. JPB consented to the assignment by ARINC and assumption by Wabtec of all the rights and obligations under the agreement in accordance with the terms and conditions to continue Services prior to the expiration date of August 31, 2025.

Staff determined that a sole source contract award is justified because Wabtec has a unique capability to perform the needed Services, and its Intellectual Property (IP) rights preclude competition, and the contract is for continued development of highly specialized systems such as ROCS, PADS and SCADA. After the acquisition, Wabtec holds proprietary ownership and licensing rights, and provides JPB with a comprehensive support service for the key components of Caltrain's Train Control System. These systems include ROCS, SCADA, and PADS. ROCS is the train computer aided dispatch system, SCADA refers to electrification and traction power control systems, and PADS is the real-time station's passenger visual and audio information system with social media integration. Wabtec is the sole vendor able to provide and deliver specialized support and services for these Systems, which have been in service since 2014.

The scope of the MSA includes:

- Maintenance and Support Services at an annual fixed price plus escalation, estimated at \$2,872,553 over five years, based on projected Consumer Price Index for All Urban Consumers. This includes, but is not limited to:
 - 24/7 emergency helpdesk
 - Troubleshooting and rail revenue service operational impact resolution
 - Hardware and software repair
 - Non-critical routine technical consultation
 - Routine maintenance and testing such as health checks and defects and bug resolution
 - Periodic and routine inspections
- Additional As-Needed Services, to be executed via negotiated Work Directives (WDs), are estimated at \$1,110,000 over five years. This includes, but is not limited to:
 - Periodic Updates to Systems to ensure Governmental Regulatory Compliance
 - Periodic Updates to Systems to maintain Positive Train Control (PTC) Interfaces
 - Technology refresh of ROCS, PADS, and SCADA Systems in Year 4

Staff requested a proposal from Wabtec to provide the Services for the Systems for a five-year term. Wabtec submitted a proposal, and a selection committee (Committee), composed of qualified staff from Rail Systems Engineering, reviewed the proposal and determined that Wabtec's proposal met all the JPB's requirements. The Committee also determined that Wabtec possesses the depth of experience and required qualifications to successfully perform the scope of services. Staff negotiated contract terms and conditions, including price, with Wabtec. Staff conducted a price analysis and determined Wabtec's prices to be fair, reasonable, and consistent with those currently paid by the JPB.

Budget Impact

This contract will be funded by a variety of funding sources which may include State, Regional, and Local revenues and grants from approved and future operating budgets.

Purpose and Recommended Action

Award of this proposed contract for Mobile App Parking Services (Services) to ParkMobile, LLC will ensure the Peninsula Corridor Joint Powers Board (JPB) maintains continued mobile parking services as the current Caltrain mobile app, contracted with moovel North America, LLC (moovel), expires on October 31, 2025, and will be phased out as part of the transition to Clipper 2.0.

Staff proposes that the Finance Committee recommend that the Board of Directors (Board) of the JPB:

- 1. Award a cooperative purchasing contract to ParkMobile, LLC of Atlanta, Georgia (ParkMobile) to provide the Services, governed by a cooperative agreement administered by OMNIA Partners (OMNIA) following a competitive procurement conducted by the Region 14 Education Service Center (ESC), as the lead agency, for a total estimated amount of \$900,000.
- Authorize the Executive Director or designee to execute a contract with ParkMobile, LLC
 in full conformity with the terms and conditions of ESC Contract Number 158974 and
 the negotiated cooperative purchasing contract, and in a form approved by legal
 counsel.

Discussion

The current vendor Caltrain Mobile app provider, moovel, provides both mobile fare ticketing and mobile parking payment services. However, with the upcoming implementation of the Clipper Next Generation system (Clipper 2.0), the JPB will discontinue all third-party mobile fare payment options to avoid market confusion and redundancy with Clipper's expanded

functionality. Simultaneously, moovel has significantly increased its fees in the final stages of its contract with JPB, prompting the JPB to accelerate the transition.

ParkMobile offers a no-cost implementation, structured fixed fees, and a simplified user experience focused solely on mobile parking payments. This contract will enable Caltrain to maintain uninterrupted mobile parking functionality while the JPB reassesses its long-term strategy for parking technology integration. The ParkMobile platform is widely used across California, offering strong compatibility with our existing enforcement systems and a familiar interface for customers.

The JPB's Procurement Manual allows the JPB to utilize cooperative purchasing agreements for procurement of common goods and services to save time and resources, and to leverage collective buying power and ensure favorable pricing based on economies of scale.

On November 15, 2024, on behalf of OMNIA Partners, the Region 14 Education Service Center (ESC) entered into an agreement for Parking Meters, Software, Systems and Related Products (Contract Number 158974) and Services with ParkMobile, LLC of Atlanta, Georgia (ParkMobile), which is valid through November 30, 2029 (ESC Contract). This ESC Contract allows all state agencies, institutions of higher education, political subdivisions, and other eligible entities in the State of California to utilize its terms and conditions, including pricing.

Staff and legal counsel reviewed the ESC Contract and solicitation documents with ParkMobile and found that it was competitively solicited and awarded in accordance with public procurement standards, supporting transparency, fairness, and legal compliance. Staff further determined that the solicitation conducted by the ESC satisfies the JPB's competitive procurement requirements. OMNIA administers cooperative contracts that are competitively solicited by lead public agencies nationwide. Staff negotiated reductions from the ESC price list on the merchant processing fees and removal of the annual escalation costs resulting in a savings of approximately 18 percent over the life of the agreement.

Budget Impact

This contract will be funded through transaction-based commissions and fees generated from parking revenues. No new net operating cost is anticipated, as expenses are directly tied to the amount of revenue collected. Funding will be included in current and future years' approved operating budgets.

Purpose and Recommended Action

Staff of the Peninsula Corridor Joint Powers Board (JPB) have identified three surplus gallery cars and one surplus diesel locomotive that have surpassed the end of their useful lives, in accordance with Federal Transit Administration (FTA) regulations and guidance. These vehicles are no longer fit for service due to damage sustained in a March 2022 accident.

Staff recommends that the Board of Directors (Board) of the JPB authorize the Executive Director, or designee, in collaboration with the Director of Contracts and Procurement, to dispose of three surplus Nippon Sharyo gallery cars and one surplus General Motors-EMD F40PH-2 diesel locomotive, in accordance with the JPB Procurement Policy.

Discussion

On March 10, 2022, a Caltrain train struck track equipment and construction vehicles engaged in construction activities in San Bruno as part of the electrification project. As a result of this incident, one General Motors-EMD F40PH-2 diesel locomotive and several Nippon Sharyo gallery cars sustained significant damage. Great American Insurance Company deemed one gallery car a total loss, while the locomotive was deemed repairable. However, given that both cars were nearing the end of their useful life, the agency opted to not repair the units prior to retirement. The totaled Nippon Sharyo gallery car and the damaged General Motors-EMD F40PH-2 diesel locomotive are the only units involved in this incident that have not yet been disposed of by the JPB.

The JPB also has two other Nippon Sharyo gallery cars that have been retired due to extensive accident damage from other incidents but have not yet been disposed of by the JPB. These vehicles are the only remaining portion of Caltrain's legacy fleet. These vehicles were built between 1985 and 1987 and have reached the end of their useful lives. The last remaining equipment is currently stored at the Central Equipment Maintenance and Operations Facility

(CEMOF) in San Jose and at the 4th and King railyard in San Francisco while awaiting final disposition. While there is no additional storage fee associated with the storage of these cars, staff recommend disposition of these assets because they have become subject to continuous vandalism and trespassing, which create unsafe conditions for Caltrain employees and contractors, particularly in the San Francisco yard. All cars are retired from service and have significant accident damage. Therefore, these cars are not in condition to be put into revenue service and are no longer needed. Additionally, the longer the cars sit idle, the more difficult it becomes to dispose of these units as their value and condition further depreciates.

The JPB will retain sufficient locomotive and cars to provide revenue service for Gilroy operations and fleet resiliency purposes. If the proposed disposition is approved by the Board, staff will proceed with a procurement process to dispose of all three gallery cars and the single locomotive.

The JPB Procurement Policy provides four methods of disposition for surplus or scrap items: (1) transfer or sale to other public agencies; (2) trade-in as part of a new procurement; (3) sale by auction, advertisement for sealed Bids, or negotiation; and (4) where appropriate, proper recycling, disposal, or donation to a non-profit entity. The Director of Contracts and Procurement, working closely with JPB Executive staff and members of the Finance, Legal and Rail Operations teams, are determining the best procurement method(s) for final disposal of the equipment. The JPB has been approached by a railroad restoration museum in Oklahoma, the Midwest Overland Rail Preservation Society, to donate the vehicles subject to this disposition. The museum has volunteered to accept all costs associated with removal of the vehicles from Caltrain properties. Due to the damaged nature of the vehicles, if Caltrain were to pay for the removal and scrapping of these vehicles, the cost was estimated to be \$460,000.00.

Budget Impact

The current costs for transport and offsite storage of the surplus gallery cars and locomotive are covered through the Fiscal Year (FY) 2024 and FY25 operating budgets. No additional budget impacts are anticipated from the disposition of the gallery cars and locomotive.

Whereas, the museum has agreed to use the locomotive for display purposes only and not to move the locomotive under its own power; and

Whereas, JPB staff recommends that the Board of Directors authorize disposal of the remaining Gallery Cars and Locomotive not identified for Gilroy Service or spare ratio purposes once the EMU trainsets are delivered and placed in mainline revenue service.

Now, Therefore, Be It Resolved that the Board of Directors approves the resolution and authorizes the Executive Director or designee to dispose of three Nippon Sharyo passenger gallery cars and one General Motors-EMD F40 diesel locomotive in accordance with the District's Procurement Policy.

Staff recommends that the Board of Directors (Board) of the Peninsula Corridor Joint Powers Board (JPB):

- 1. Authorize Amendment Number 2 to the Construction Manager/General Contractor (CMGC) Support Services Contract with Flatiron-Herzog Joint Venture (FHJV) to increase the contract budget by the not-to-exceed amount of \$2,782,279.33, from \$2,500,000 to \$5,282,279.33, with 10 percent contingency, for the Broadway Burlingame Grade Separation Project (Project).

Discussion

On August 7, 2025, the JPB Board formally approved Caltrain's contribution of \$3.83 million towards the agreed upon \$15.3 million 65 percent redesign and right-of-way (ROW) support budget for the Project. Additionally, the Board approved the execution of separate Memoranda of Understanding (MOU) with the San Mateo County Transportation Authority (TA) and the City of Burlingame to define the parties' roles and responsibilities for the redesign effort. The goal

of the redesign is to reduce complexity, minimize long-lead risks, and improve the Project's readiness for external funding.

Total cost of the 65 percent redesign and ROW support effort is \$15.3 million; the following table depicts the cost breakdown by elements:

Budget Impact

The contract capacity increases of \$2,782,279.33 for the CMGC Support Services Contract and \$7,178,492 for the Designer Contract are included in the JPB-approved 65 percent re-design budget of \$15.3 million.

Purpose and Recommended Action

Staff recommends that the Board of Directors of the Peninsula Corridor Joint Powers Board (JPB or Caltrain) approves an agreement with the California Department of Transportation (Caltrans) for the lease of three F-40PH-2C locomotives, three Bombardier cab cars, and 13 Bombardier coach cars. The agreement provides for the lease of these vehicles at a monthly rate of \$12,300 per locomotive, \$10,000 per cab car, and \$8,600 per coach car, totaling \$2,144,400 annually.

Discussion

With the launch of electrified service, Caltrain currently has surplus diesel rolling stock. Rather than storing, maintaining, and insuring idle equipment at cost, staff have negotiated a lease agreement with Caltrans that will support the state's intercity and commuter rail operators - Capitol Corridor Joint Powers Authority (CCJPA), Altamont Corridor Express (ACE), and the San Joaquin Joint Powers Authority (SJJPA) - which are experiencing equipment shortages due to increased ridership demand.

This lease supports statewide mobility and rail recovery efforts by supplying urgently needed, service-ready rail vehicles to California's intercity and commuter rail operators. By entering into this agreement, Caltrain will help the State meet pressing public transportation needs while demonstrating effective stewardship of public assets.

Under the terms of the lease, Caltrans and the San Joaquin Regional Rail Commission will assume full responsibility for maintenance, insurance, and storage of the equipment, which will result in additional operating savings to Caltrain, as Caltrain will be relieved of the need to maintain, store and carry liability insurance for the leased equipment.

Caltrain has received Federal Transit Administration (FTA) Section 5337 formula funds used to procure new electric multiple unit (EMU) trainsets to replace the three F-40PH-2C locomotives . Once those EMU vehicles are delivered and placed in revenue service, Caltrain plans to retire the three locomotives from its fleet inventory. The recommended lease allows Caltrain and Caltrans the option to negotiate for a permanent transfer of ownership for those units, subject to state and federal requirements.

The lease agreement is for a term of five (5) years. However, either party may terminate the lease as to all or a portion of the Equipment for any reason with 90 days' written notice. In addition, if Caltrain needs one or more pieces of equipment as a result of damage to its current fleet, partial termination of the lease is allowed upon providing reasonable notice to Caltrans, without being subject to the 90-day notice requirement. This flexible arrangement allows both agencies to adapt to future fleet or operational changes as needed.

Budget Impact

The lease will generate annual revenue of approximately \$2.14 million.

In addition to the lease revenue and operational benefits of freeing storage space, Caltrain will avoid costs associated with maintenance and inspection and insurance for this equipment. Staff estimate \$500,000 annual savings from the following two items:

• Maintenance: \$350,000 per year

Insurance: \$150,000 per year

The synergistic effect of lease revenue and avoided costs is projected to yield substantial positive impacts on Caltrain's operating budget over the duration of the lease. This agreement directly supports Caltrain's strategic objectives of enhancing financial stability by implementing cost efficiencies and securing non-farebox revenue to mitigate anticipated operational deficits. Furthermore, it will contribute to broader regional mobility initiatives, expanding transportation alternatives for Californians.

Purpose and Recommended Action

Staff recommends that the Board of Directors (Board) of the Peninsula Corridor Joint Powers Board (JPB or Caltrain):

- 1. Authorize the Executive Director, or designee, to execute a funding agreement with Santa Clara Valley Transportation Authority (VTA) in a form approved by legal counsel for Caltrain to use both Regional Measure (RM) 3 and Measure B funds for the Diridon Station Redevelopment Project Environmental Process.
- 2. Amend the Fiscal Year 2026 (FY26) Capital Budget to increase it from \$34,831,992 to \$66,491,608
- 3. Authorize the Executive Director, or designee, to file any other required documentation or take any other actions necessary to give effect to these actions.

Discussion

Caltrain, VTA, the City of San José, the Metropolitan Transportation Commission (MTC), and the California High-Speed Rail Authority (CHSRA) (Partner Agencies) are working together on the Diridon Station Business Case to plan for the transformation of San Jose's downtown transit hub. The station, owned by the JPB, currently serves Caltrain, Capitol Corridor, Altamont Corridor Express (ACE), and Amtrak passenger rail, as well as VTA light rail (LRT) and bus services, and other bus operators. Diridon Station must accommodate both future services increases by current operators as well as accommodate as future services, including new

CHSRA, Bay Area Rapid Transit (BART), and San Jose Airport Connector services. To effectively accommodate planned and future services, Diridon Station must be reconfigured, expanded, and upgraded to provide adequate capacity, functionality, and interconnectivity for passengers.

For the next phase of program advancement, the Partner Agencies have developed work scopes and budgets for National Environmental Policy Act (NEPA)/California Environmental Quality Act (CEQA) environmental review, long-term governance, and funding and advocacy strategies, and prepared a funding plan. On May 21, 2025, staff presented the funding plan to the Diridon Steering Committee, which is charged with coordinating the actions of the Partner Agencies and which approved the funding plan.

Caltrain's scope of the Diridon Station Redevelopment Project Environmental Process Project work will be funded using Measure B and Regional Measure 3 (RM3) funds. Measure B Caltrain Corridor Capacity Improvements funding for this project was identified in May 2025 as part of the 2016 Measure B FY26 and FY27 Biennial Budget and is administered by VTA. The RM3 Expenditure Plan, administered by MTC via agreement with VTA, allocates \$100 million in capital funding for the San José Diridon Station. Since VTA receives the funds directly from MTC, Caltrain will enter into a funding agreement with VTA for Caltrain to access these funds.

Therefore, staff recommends the Board authorize the Executive Director, or designee, to execute a funding agreement with VTA for Caltrain to access the Measure B and RM3 funds.

Environmental Process Scope

The largest portion of the FY25-28 budget is the environmental review scope. Caltrain will lead the environmental review process including holding contracts for appropriate technical consultants. As such, Caltrain will be responsible to prepare an Environmental Impact Statement (EIS) pursuant to NEPA and an Environmental Impact Report (EIR) pursuant to CEQA. The documentation will be done jointly, preparing a Joint EIS/EIR as prescribed under applicable California and federal laws, regulations and guidelines.

This process will include the necessary engineering and design tasks to support the analysis and findings of the environmental documents. This component of the scope will build upon and advance the conceptual engineering completed as part of the recently concluded Alternatives Development process, and is essential for establishing the ultimate project limits, construction requirements and a stable project description. The engineering and design tasks are a substantial component of this overall scope of work; however, the ultimate deliverables are the environmental documents necessary for state and federal environmental clearance.

More specifically, the following activities are required:

- Conduct NEPA/CEQA Environmental Review. Key tasks include:
 - Project Kickoff
 - Prepare Alternatives Analysis Report (summarization of the Alternatives Development)
 - Share designs with 3rd parties and obtain comments
 - Develop Project Description
 - Prepare needed engineering and design
 - Prepare required technical studies
 - Conduct public participation and community engagement
 - Issue Notice of Intent / Notice to Proceed
 - Conduct CEQA and NEPA Public Outreach
 - Prepare and circulate Admin Draft, Draft EIS/EIR
 - Prepare Response to comments and Final EIS/EIR and circulate
 - Obtain Certification and Record of Decision

Budget Impact

The proposed amendment increases the FY26 Capital Budget from \$34,831,992 to \$66,491,608, providing Caltrain with the budget authority to implement the RM3 and Measure B funding agreements included in this item.

Purpose and Recommended Action

Award of this proposed contract for the Diridon Station Redevelopment Project (Project) Environmental Phase Services (Services) will provide the Peninsula Corridor Joint Powers Board (JPB) with a qualified firm to prepare environmental documentation in compliance with the National Environmental Policy Act (NEPA) and the California Environmental Quality Act (CEQA). The contract also includes engineering and design tasks necessary to support the analysis and findings of the environmental documents. This work will result in final environmental documents that satisfy NEPA and CEQA requirements and achieve environmental clearance for the Project.

Staff proposes that the Advocacy and Major Projects Committee recommend that the Board of Directors (Board) of the JPB:

- Award a contract to ICF Jones & Stokes, Inc. of Reston, Virginia (ICF) to provide the Services for the Project for a total not-to-exceed amount of \$21,101,357 for a three-year base term, with up to two additional one-year option terms for up to \$1 million per option year.
- 2. Authorize the Executive Director or designee to execute a contract with ICF in full conformity with the terms and conditions of the solicitation documents and negotiated agreements, and in a form approved by legal counsel.
- 3. Authorize the Executive Director or designee, to exercise up to two additional one-year option terms, if deemed in the best interest of the JPB.

Discussion

The JPB is part of a five-agency partnership for the Diridon Station Redevelopment Program of Project. The JPB is responsible for carrying out the environmental review on behalf of the partnership for the Project. On May 22, 2025, the Diridon Steering Committee approved the At-Grade Alternative and associated program of projects to be advanced through environmental review. On June 6, 2025, the JPB Board approved the Steering Committee's action. An environmental consultant will help the JPB fulfill these responsibilities by providing specialized expertise and support services.

On January 29, 2025, the JPB issued Request for Proposals (RFP) 25-J-P-061 to provide the Services for the Project. The RFP was advertised on the JPB's eProcurement website. Staff performed pre-proposal outreach to certified Disadvantaged Business Enterprises (DBEs) and Small Business Enterprises (SBEs). Staff held a virtual pre-proposal conference on February 13, 2025; three potential proposers and twelve potential subconsultants attended. By the March 26, 2025, due date, the JPB received responsive proposals from two firms:

- ICF Jones & Stokes, Inc. of Reston, Virginia (ICF)
- Circlepoint of Oakland, California (Circlepoint)

A Selection Committee (Committee), composed of qualified staff from the JPB Planning Department, California High Speed Rail Authority, City of San Jose, Metropolitan Transportation Commission (MTC), and Santa Clara Valley Transportation Authority (VTA), evaluated, scored, and ranked these proposals in accordance with the following weighted criteria:

After the initial scoring of proposals, one firm was found to be the highest ranked and was interviewed. Following the interview, the Committee determined that the highest ranked firm, ICF, possesses the requisite experience and qualifications required for the successful performance of the scope of services as defined in the solicitation documents.

Staff successfully negotiated contract terms, including prices, with ICF. Staff also conducted a price analysis and determined the negotiated prices to be fair, reasonable, and consistent with the prices currently paid by the JPB and other public agencies in the Bay Area for similar services.

ICF is committed to utilizing SBEs for this contract. The JPB may assign DBE goals if federal funding is secured.

Budget Impact

On May 21, 2025, the Diridon Steering Committee approved the three-year budget (Fiscal Years 2025-2028) for the Diridon Station Redevelopment program environmental phase. This includes the full cost of the consultant contract for environmental services. The environmental phase of the project, including this contract, will be funded by MTC's Regional Measure 3 (RM3) and VTA's Measure B funding. Allocation of RM3 funds is anticipated at the September 24, 2025, MTC Commission Meeting. As described in another item on this Agenda, the RM3 and Measure B funds will be provided via funding agreements with MTC and VTA, which are anticipated to be completed in October 2025. Staff will not issue Notices to Proceed pursuant to this agreement until the funding agreements are executed.

IN HONOR OF RAILROAD SAFETY AND SUICIDE PREVENTION MONTH

Whereas, Caltrain operates 104 weekday trains between San Francisco and Gilroy, serving the Peninsula Rail Corridor, and the communities of San Francisco, San Mateo and Santa Clara counties; and

Whereas, safety on the Caltrain right of way has been and remains a continuing priority along a rail system that traverses several communities and includes more than 50 at-grade public vehicular and pedestrian crossings; and

Whereas, the Peninsula Corridor Joint Powers Board works continuously with essential partners, including the Federal Railroad Administration, California Department of Transportation, California Public Utilities Commission and California Operation Lifesaver to improve railroad safety, prevent accidents and educate the public about safety around railroad tracks; and

Whereas, Caltrain recently received the 2025 Commuter Rail Safety Gold Award from the American Public Transportation Association (APTA) in recognition of the many efforts the agency has undertaken to make the railroad safer; and

Whereas, in the last year alone, Caltrain has installed multiple infrastructure improvements designed to prevent fatalities, including AI technology, anti-trespasser panels, improved markers and delineators, stop bars, and improved signage, including the addition of new 988 suicide prevention signs along the corridor and at stations; and

Whereas, suicide is a mental health issue that Caltrain is all too familiar with as many deaths occurring on railroad tracks are ruled suicides; and

Whereas, Caltrain partners with the San Francisco Department of Public Health, the San Mateo County Suicide Prevention Committee, StarVista, Project Safety Net, and the County of Santa Clara Behavioral Health Services, to publicize resources available for individuals in crisis to reduce deaths by suicide on the rails; and

Whereas, during the month of September, Caltrain staff will post rail safety tips and suicide prevention resources through its social media platforms and will participate with the Transit Police in a Rail Safety Blitz event to educate drivers and pedestrians at specified grade crossings with rail safety educational brochures. Caltrain also will provide suicide prevention training for employees.

Therefore, Be It Resolved, that the Peninsula Corridor Joint Powers Board (Caltrain), in support of safety efforts locally, regionally, and statewide, joins in proclaiming September as "Railroad Safety and Suicide Prevention Month" and commends local, State, and Federal officials, industry, and citizen efforts to improve railroad safety.

RE: STATE LEGISLATIVE UPDATE – September 2025

General Update

The Legislature is on Summer Recess from July 18 until August 18. Once the Legislature returns, fiscal committees will have until August 29 to hear and pass bills to the floor of each house. As a reminder, bills with a nominal fiscal impact to the state are referred to the appropriations committees' suspense files. August 29 will be the appropriations committees' suspense file hearings. If bills pass the fiscal committees, they are moved to the floors of each house for final votes. Bills will need to be in their final form 72 hours prior to final votes. The Legislature will recess the first year of the two-year 2025-26 Legislative Session on September 12. For information about key legislative and budget deadlines, please see the 2025 Legislative Calendar available here.

With only about a month left in the first year of the two-year Legislative Session, the Legislature still has several big-ticket transit-related items to address before adjourning for the year on September 12. This list is headlined by Cap-and-Trade expenditure plan and possible re-authorization, the proposed \$750 million loan to Bay Area transit agencies, and the Bay Area Regional Measure.

Cap-and-Trade Re-Authorization

As we have discussed in previous reports, the Legislature has largely avoided acting on the Governor's proposal to extend and amend the Cap-and-Trade program and Greenhouse Gas Reduction Fund since Governor Newsom announced it as part of his May Revise. While there does seem to be urgency to act quickly to reassure the markets before the next allowance auction, scheduled for August 20, it does not appear likely that a deal will be struck by then. If May's auction is any indication, the State may be in for another very poor set of proceeds to fund the GGRF pot that the Legislature, Governor, and advocates are fighting over. In the final month of session, the Legislature and the Governor could agree to extend the program and leave the allowance allocations/funding programs for another day, essentially leaving the current program in place. They could also agree to extend the program and alter the funding programs in order to address current administration and legislative priorities, including specified funding for the high-speed rail (HSR) project or energy affordability. In any case, it will surely be a big lift if the Legislature and Governor are to get this done in the final month.

Bay Area HSR Joint Benefit Project partners staff are in discussion regarding priorities for a potential Cap-and-Trade Re-Authorization negotiation.

Bay Area Transit Loan

At the start of 2025, Senator Jesse Arreguín (D-Berkeley) and Assemblymember Mark Gonzalez (D-Los Angeles) proposed that the Legislature allocate \$2 billion in new monies for transit agencies across the State. After the Governor's May Revision revealed California was facing a \$12 billion deficit, that effort seemed like a long shot. Instead, the Governor and Legislative leaders agreed to a \$750 million emergency loan for Caltrain and three other Bay Area transit agencies (AC Transit, BART, and SF Muni). Pursuant to the <u>Budget Act</u>, this emergency loan is generally conditioned upon the agencies having repayment plans *and* the passage of the Bay Area Regional Measure authorizing legislation. Additional details have been scarce, but the impacted agencies are working on loan terms to share with Bay Area legislators, and we expect the Department of Finance to be engaged as these details are finalized and agreed to amongst the parties. The biggest sticking point will be: how do these loans get repaid if the Bay Area Regional Measure fails.

Bay Area Regional Measure

The Bay Area Regional Measure, ensconced in SB 63 (Wiener and Arreguín), continues to move through the legislative process. This bill seeks to generate additional revenue to support the Bay Area's public transit systems. After passing the Senate Floor on June 2, the bill passed to the Assembly, where it was heard in its first policy committee – the Assembly Transportation Committee – on July 7. The bill passed the Committee on a party-line vote of 11-4. However, before passing, the author accepted Committee amendments that prioritize the operations of the San Francisco Bay Ferry (WETA) service and the East Bay bus systems over funding for transit transformation, while also reducing the transit transformation pot from 10 percent to 5 percent. Additionally, because the legislation is not in its final form, the author and the Chair agreed that the bill would again be heard in the Committee before the end of the Legislative Session, which is September 12.

The bill, as currently drafted, would authorize a citizens' initiative, which may only require a simple majority vote, for a sales tax of one-half cent in Alameda and Contra Costa Counties, and up to one cent in San Francisco County. These taxes could be applied for 10-15 years. The bill is currently a three-county measure (Alameda, Contra Costa, San Francisco) but provides a path for San Mateo and Santa Clara counties to opt-in before August 11, 2025.

The bill now proposes to allocate revenues to AC Transit, BART, Caltrain, Muni, County Connection, Tri Delta Transit, LAVTA, Union City Transit, WestCAT and SF Bay Ferry, and those revenues may only be used for transit operations. The measure would also provide up to 5 percent (down from 10 percent) of the revenues for transit transformation to be controlled by MTC and up to 1 percent of revenues for administration of the regional measure for the Transportation Revenue Measure District Board. The bill also currently requires performance audits of the major transit systems facing fiscal cliffs (AC Transit, BART, Caltrain, SF Muni), as well as provisions for stronger regional network management and authorizes a regional network manager to implement the network management framework in exchange for access to SB 63 funds.

On July 23, Senators Wiener and Arreguín sent a letter to MTC and county transportation agencies outlining their proposed expenditure plan for the five counties presumed to join the measure. The proposed expenditure plan assumes Alameda, Contra Costa, San Mateo, and Santa Clara Counties all pass a one-half cent sales tax and the City and County of San Francisco passes a one cent sales tax, all of them in effect for 14 years. This expenditure plan proposes that Caltrain receive 7 percent of the total revenue from the tax measure – predicted to be approximately \$75 million annually by Fiscal Year 2031.

On July 30, both the San Mateo County Transportation Authority and the City/County Association of Governments (C/CAG) of San Mateo County voted to recommend the SamTrans Board support San Mateo County opting in to the regional measure through SB 63 with requests to review accountability proposals that have been received. On August 6, the SamTrans board voted 8 to 1 to opt in to the regional measure. On August 7, the VTA board voted 12 to 0 to opt in to the regional measure.

This bill is in the Assembly Appropriations Committee. If it passes through that committee, it is likely to return to the Assembly Transportation Committee for a hearing the week of September 1. Caltrain is in support of SB 63.

Continued SB 30 Engagement

Caltrain and its state advocates have taken the lead in working with California's other rail agencies to engage with Senator Cortese and secure changes to his SB 30, a bill introduced in response to Caltrain's agreement to transfer trainsets to Peru last Fall which was given a waiver approval by the Bay Area Air Quality Management District citing a federal analysis of the environmental benefits of the transfer. Caltrain's state advocates, in partnership with the California Transit Association, have actively worked to secure favorable amendments to the legislation. Originally, SB 30 would have prohibited a public entity that owns any diesel-powered on-track equipment from selling, donating, or otherwise transferring that equipment for continued use after the public entity ceases the service of on-track equipment by replacing it with lower emission on-track equipment. After several months of engagement by CTA and rail agencies, the bill now permits a public entity to transfer Tier II, Tier III, and Tier IV locomotives, or an emissions equivalent locomotive, if authorized at a public meeting. However, the bill continues to prohibit the transfer of Tier 0 or Tier I locomotives, which presents issues for Caltrain, given their fleet of Tier 0 and I trainsets. Caltrain continues to own 9 diesel locomotives as well as other diesel on-track equipment. The inability to transfer this equipment represents a direct asset and lease revenue loss to Caltrain of a minimum of \$20 million and likely more depending on markets, leasing, and inflation. At a time where Caltrain and other rail agencies in the state are facing fiscal uncertainty, this direct loss of asset value and non-fare revenue is particularly challenging. The bill does not acknowledge the mobility or air quality benefits of passenger rail transit from reduced vehicle miles traveled. The bill only applies to public agencies and does not include private freight railroads which hold 99% of all diesel locomotives in the state of California. Caltrain is seeking amendments that would exempt Tier 0 or I locomotives if the agency can demonstrate a net air quality benefit to the transfer as well as clarifying amendments on engine disablement.

SB 30 is now in the Assembly Appropriations Committee, and Caltrain's state advocates continue to work to secure further amendments. SB 30 is now in the Assembly Appropriations Committee. Caltrain has a SUPPORT IF AMENDED position on this bill as it works to address the remaining issues noted above.

Bills with Positions

SB 63 (Wiener) Regional Measure - SUPPORT

This bill seeks to generate additional revenue to support the Bay Area's public transit systems by way of a regional transportation measure. **This bill is in the Assembly Appropriations Committee.**

SB 71 (Wiener) CEQA Exemptions for Transit Projects – SUPPORT

Co-Sponsored by the California Transit Association, this bill, as amended July 17, would extend the current January 1, 2030 sunset date established by SB 922 (Wiener, 2022) for statutorily authorized CEQA exemptions for transit and transportation projects to January 1, 2040s, add additional project-types to the list of exemptions (ferry terminals, transit operational analysis, bus stops, bus shelters), and

make substantive procedural changes surrounding board actions (i.e. board process for establishing a project's cost estimate). Caltrain previously supported SB 922, as well as AB 2503 (Lee, 2024), which added to the list of statutory exemptions an exemption for zero-emission rail. **This bill is in the Assembly Appropriations Committee.**

AB 394 (Wilson) Transit Safety -- SUPPORT

Co-Sponsored by the California Transit Association, this bill would enhance the safety and security of California's public transportation systems by strengthening protections for transit operators, employees, and passengers. The bill accomplishes this goal by expanding existing law (Penal Code Section 243.3) to protect all transit employees against battery. Further, AB 394 clarifies that our state's public transit operators are employers for purposes of seeking a temporary restraining order (TRO) against violent offenders. The Amalgamated Transit Union, Teamsters, and SMART-TD are co-sponsors of this bill. **This bill is in the Senate Appropriations Committee.**

AB 476 (M. González) Metal Theft – SUPPORT

Co-sponsored by the City of San Jose, this bill seeks to combat the theft of copper wire — an increasing problem affecting infrastructure, construction, and transit projects. The bill would require junk dealers and recyclers to collect more detailed transaction records and provide access to these records to law enforcement. The bill also requires that people selling copper obtain a state license and increases the fine for junk dealers or recyclers who fail to follow the law. **This bill is in the Senate Appropriations Committee.**

Bills of Interest

SB 79 (Wiener) Transit Oriented Development

This bill would require that a housing development proposed within one-half or one-quarter mile of a transit-oriented development stop be an allowed use on any site zoned for residential, mixed, commercial, or light industrial development. A transit-oriented development stop is defined as a site within an urban transit county served by heavy rail transit or very high frequency commuter rail (Tier 1); a site within an urban transit county served by light rail transit, by high frequency commuter rail, or specified bus service (Tier 2); or, a site within an urban transit county served by frequency commuter rail, or by specified bus service (Tier 3). SB 79 also requires that the development be eligible for streamlined, ministerial approval. **This bill is in the Assembly Appropriations Committee.**

SB 545 (Cortese) High-Speed Rail Economic Opportunity Study

This bill requires the State's Office of Land Use and Climate Innovation to study economic opportunities along the High-Speed Rail Corridor. The study will examine strategies such as land value capture, development incentives, and public-private partnerships. This will help ensure California maximizes the economic potential of the HSR project and its station areas. In addition, SB 545 requires an infrastructure district that uses its revenues to finance the construction of the HSR project to dedicate a majority of its revenue to infrastructure projects *within* the jurisdiction of the local agencies that established the district. **This bill is in the Assembly Appropriations Committee.**

SB 707 (Durazo) Brown Act Reform

This bill, as amended July 17, would make a number of changes to the Brown Act. Including new public access and participation requirements for specified legislative bodies, new exemptions from certain teleconferencing requirements for eligible subsidiary bodies and eligible multi-jurisdictional bodies, and extensions of law providing exemptions from certain teleconferencing requirements for specified legislative bodies or under specified circumstances. This bill contains several other provisions related to the Brown Act, including that certain special districts provide agenda translations and to reasonably

assist members of the public with translation services, but does not require an agency to provide an interpretation for a meeting. This bill is in the Assembly Appropriations Committee.

Congressional Update

Senate Passes First Appropriations Minibus Ahead of August Recess

- On August 1, the Senate passed its first three spending bills: Agriculture-FDA, Military Construction-Veterans Affairs, and Legislative Branch. All three bills had bipartisan support. In the House, members were only able to pass their Defense and Military Construction-Veterans Affairs measures.
- However, it is still highly unlikely that Congress will be able to pass all 12 appropriations bills before the current federal funding expires on September 30. Congress is likely to consider a continuing resolution (CR) to avoid a government shutdown on October 1. Nonetheless, Senate leadership has expressed a desire to have at least some full-year bills sent to the President's desk while some House members continue to advocate for another long-term CR.
- Potential implications of a government shutdown could impact the functions of federal departments. Federal workers could be asked to stay and work without pay or be furloughed if they are considered nonessential. Coordination with regional offices of federal departments could slow, as well as the agencies' work on pending grant applications.

House and Senate Release Respective Transportation-HUD Funding Bills

- In July, the House and Senate released their versions of the Transportation-HUD funding bill head of the September 30 funding deadline. Generally, Senate appropriators allocated more funding than the House for many transportation programs.
- The below table summarizes the funding levels for relevant programs within the Department of Transportation (DOT) for Caltrain:

Senate Confirms Marc Molinaro as FTA Administrator in Bipartisan Vote

- On August 2, the Senate confirmed former Congressman Marc Molinaro to lead the Federal Transit Administration (FTA). The 73-21 vote comes four months after the Senate Banking, Housing, and Urban Affairs Committee approved his nomination. Since April, Molinaro has served as a senior advisor to Department of Transportation (DOT) Secretary Sean Duffy on transit issues.
- Molinaro represented New York's 19th congressional district from 2023-2025 and was
 the county executive for Dutchess County, New York from 2012-2023. Over the past few
 months, he has outlined his priorities for the FTA, notably focusing on the 11 U.S. cities
 that will host FIFA World Cup Games next year. He has also pledged to allow
 nonpartisan career staff at the FTA to oversee safety enforcement.
- Former Acting Administrator Tariq Bokhari will serve as Deputy Administrator. Bokhari did not require Senate confirmation and has therefore served as Acting Administrator since the start of the Trump Administration.

Senate EPW Holds Hearing on Surface Transportation Reauthorization Perspectives

North Dakota Governor Kelly Armstrong, and Austin Ramirez, CEO of Husco International.

- As the current reauthorization, enacted through the Infrastructure Investment and Jobs Act (IIJA), is set to expire next year, Senators questioned witnesses on changes and improvements the Committee can make in the next bill to better address the country's surface transportation needs.
- Witnesses stressed the importance of providing formula funding that gives states
 flexibility to address their specific needs, investing in infrastructure resilience and climate
 adaptation, and streamlining permitting reform to shorten project delivery timelines.
 There was broad bipartisan agreement on the need to build safe, efficient, and reliable
 transportation systems, especially in rural areas and communities vulnerable to extreme
 weather patterns.

<u>House T&I Committee Holds Hearing on DOT FY26 Budget Request and Additional Funding Priorities</u>

- On July 16, the House Transportation and Infrastructure (T&I) Committee convened a hearing with DOT Secretary Sean Duffy to discuss the Department's FY26 budget request and its programs and policies.
- Secretary Duffy focused on transportation safety and infrastructure modernization, detailing a \$12.5 billion investment from the One Big, Beautiful Bill Act (H.R. 1) in air traffic control (ATC) upgrades and the role of emerging technologies in preventing future incidents.
- The hearing included a bipartisan focus on delays in federal grant obligations, with calls for balanced infrastructure solutions and streamlined project delivery despite some partisan disagreements over equity and environmental criteria in DOT grants. Sec. Duffy defended DOT's review of over 3,200 outstanding grants and stated that, while some programs were being reevaluated, most were progressing through the review process.

Administration Update

President Trump Signs Executive Order to Change Federal Grant Process

- On August 7, President Trump signed an executive order entitled "Improving Oversight of Federal Grantmaking." The order requires a Trump Administration appointee to review funding opportunity announcements and grant awards.
- While political appointees have generally exerted at least some control over grant awards, the executive order attempts to ensure President Trump's appointees have greater say in the outflow of grant dollars. Since President Trump took office in January, his appointees
