7. Discord, Social Media Update (Lisa Peabody, Director, Customer Experience)

Lisa Peabody, Director, Customer Experience, provided the presentation that included the following:

- Caltrain began using Discord June 2025
- Social media engagement opportunities: BlueSky, Instagram, Facebook, Reddit
- Discord metrics: over 120 members joined #caltrain-bikes channel; over 520 messages
- Key themes: bike tag usage; etiquette

The Committee members had a robust discussion and staff provided further clarification in response to the Committee comments and questions, which included the following:

- Caltrain Wi-Fi during peak hours; public ability to file reports; unable to connect; connected but no service; locations of non-working Wi-Fi (Menlo Park; Lawrence to San Carlos)
- Staff acknowledgement and logging of Discord messages identifying website errors
- Caltrain's moderating frequency, bots and community moderators, goal every couple days
- Broaden audience outreach; social media campaign to bring awareness; information aboard trains; channel on bike tags
- Twitter/X usage; Caltrain moderation; Code of Conduct posted and enforcement
- Use social media for service alerts; public crowd sourcing information; marketing service alert subscription

8. Bike Page, Website discussion (Baltazar Lopez, Government Affairs Officer)

Baltazar Lopez, Government Affairs Officer, provided the presentation that included the following:

- Reviewed Bike Page Best Practices discussion points for inclusion on website
- Upcoming Silicon Valley Bike Coalition feedback

The Committee members had a robust discussion and staff provided further clarification in response to the Committee comments and questions, which included the following:

- Information missing or outdated on public website
 - o Train Types and Bikes reference to diesel trains; bike cars location
 - How to pay for bike lockers
 - Frequently Asked Questions
- Proposed list covers bicycle security or safety; split list into two sections: (1) on train, (2) on platform
- Suggestions to Add
 - Sitting in view of your bike, if possible
 - Get bike insurance check if covered by existing insurance policies
 - Securely wrap bike with bungle cord
 - o Information on what to do if bike is stolen, besides reporting to law enforcement
 - Link Bike Valet Parking options
 - Embed map of bike lockers
 - o Picture or diagram of train stations and where to wait
 - Properly labeled bike tag
 - Bike storage and bike lockers
 - Overnight bike storage at platforms: Use two locks
 - Bike rooms and eLockers

- Use special key for locking screws for wheels and seat posts
- Suggestion to Remove
 - Bike alarm (not on train; on platform)
 - Locking your wheel to the frame
- Additional feedback
 - Registering your bike; discussion on difficulties registering bike
 - Check with your local police/sheriff department; cities and counties may offer bike registration programs
 - o Rank practices in order with most easy task to complete at top
 - Ask for feedback on Discord channel and other social media
 - Explain destination tag; how to get one; how to complete
 - Encourage usage of Velcro strap for front brakes
 - Different webpage for basic bike usage best practices with instructional video, diagrams, stacking forward-backward; instructional stickers in bike cars
 - Naming of bike storage units, active mobility storage
 - Clarify bulky bike attachment, such as child seat
 - Make online theft report link easy to find
- Bike car decals and graphics at platforms and on train cars

9. Unstaffed Bike Rooms (Dan Provence, Principal Planner)

Dan Provence, Principal Planner, provided the presentation that included the following:

- Upcoming unstaffed bike rooms features: access kiosk with account verification; variety
 of bike racks; air pump and repair stations
- Redwood City Bike Room: site preparation and improvements; openings; bike and scooter spaces; pump
- Menlo Park Bike Room: seal openings; bike and scooter spaces; pump
- Sunnyvale Station: conceptual stage; use existing structure; staff in talks with City of Sunnyvale
- Hillsdale Station: conceptual stage

The Committee members had a robust discussion and staff provided further clarification in response to the Committee comments and questions, which included the following:

- Sunnyvale: auto-opener door for accessibility
- Bike pump valves versatility
- Security cameras on-site
- Using existing shade structures for bike rooms and having shade structures for riders
- Outreach to local cities of upcoming bike rooms; movement of persons around or to off property
- Connecting to BikeHub and/or BikeLink, mobile apps
