Dear Director Canepa,

With regards to undergrounding Bayshore station, the Executive Director's comments about the high water table are correct but the proposed undergrounding is achieved <u>by raising the area around the existing tracks by up to 30 feet</u>, (hopefully with tunnel spoils from the PAX and the DTX) at which point the bikes and peds (and SamTrans and MUNI buses and LRT) would cross the existing Caltrain tracks at (elevated) grade and access to the Caltrain platforms would be via escalators, stairs and inclinators.

The entire concept was modelled after London's Stratford City site (<u>a former railyard abandoned due to rising sea levels</u> and redeveloped for the 2012 Olympics) when San Francisco was considering a bid for the 2028 Olympics.

Funding for the London project came from development enabled thru land reclamation achieved through repurposing of high speed tunnel excavation materials on the approach to St Pancras station.
