

# Bicycle Thefts 2017



- Approximately 6,000 bikes onboard daily
- 101 reported bike thefts in 2017
- Average bike thefts in 2017 = 8 per month
- Only 1 bike theft was reported as being onboard Caltrain (April 2017)
- 2 Arrests were made











### Know Your Bike Info.

- Record the bike's serial number, manufacturer, and model
- Take photos of the bike and note any unique identifying markings, aftermarket components in case of theft.
- Save the receipt for insurance purposes









### Locks and Programs

- Rent a bike locker at a station.
- Participate in a Bikeshare program.
- Invest in a sturdy bike lock
- Lock your bike in a well-lit public area









#### **Be Vigilant**

- Be aware of your surroundings
- Get to know your fellow commuters and help keep an eye out for suspicious people or activities on the train

#### **Bicycle Descriptors**

- Make
- Model
- Serial Number
- Identifying markers
- Value of the Bicycle
- Aftermarket Components

#### Time of Incident

- Time Frames
- Exact location where the bike was last seen

#### Specific Location

- Onboard Caltrain
- Which stop?
- Train #
- Bike Rack
- Northbound or Southbound
- Specific Location of Bicycle Rack/Bike Locker
- Location at the station
