April 29, 2020

1. CALL TO ORDER/PLEDGE OF ALLEGIANCE

Vice Chair John Baker called the meeting to order at 6:37pm and led the Pledge of Allegiance.

2. ROLL CALL

CAC Secretary Jean Brook called the roll. A quorum was present.

3. PUBLIC COMMENT FOR ITEMS NOT ON THE AGENDA

None.

4. APPROVAL OF MEETING MINUTES FROM FEBRUARY 26, 2020

Ms. Brook noted that she would correct the order of the Roll Call and Report of the Chair. The meeting minutes were approved based on the amendments noted.

5. REPORT OF THE CHAIR

a. Certificate of Appreciation for Outgoing Member Sonny Koya

Vice Chair Baker noted that Sonny Koya was not able to attend the meeting. SamTrans Director Peter Ratto added that Mr. Koya had served three consecutive three-year terms and would be able to reapply to be on the Committee after a one-year hiatus.



6. PRESENTATION: SAMTRANS VULNERABILITY ANALYSIS RESULTS

Amelia Timbers, Principal Planner, Sustainability, provided a presentation.

Nancy Lacsamana asked if the grant money came from Measure W. Ms. Timbers said it came from SB1 funds, specifically Caltrans. Ms. Lacsamana asked about more funding in the future. Ms. Timbers noted that there was a lot of sustainable communities type of funding available. She added that the more immediate climate change impacts would receive priority in funding.

Ms. Lacsamana said she advocated the idea of setting up some sort of transportation to cooling centers during heat waves.

Vice Chair Baker remarked that the slough adjoining South Base was also in danger of flooding. He noted that there is a homeless shelter adjoining North Base. Margo Ross, Director of Bus Transportation, said that the land belongs to the District and is leased to the Safe Harbor shelter for a nominal fee.

Vice Chair Baker said that he liked Ms. Lacsamana's idea of increasing bus frequency to reduce passenger heat exposure at bus stops.

Scott Johnston asked if South Base could share costs with the San Carlos Airport. Ms. Timbers said there would likely be a state financing option.

7. SAMTRANS STAFF UPDATE

Ms. Ross noted the reduction in service and the start of rear boarding and no fares. She said the operators wear masks and that the buses are sanitized each night. She said there are now standby buses throughout the County so that people do not have more than a 15-minute wait. She thanked the bus operators who have been coming to work, noting that many operators are not reporting to work at other agencies.

Public Comment:

Andy Chow said that buses should not be crowded during this time. He said he was concerned that some people may get left behind at bus stops during busier times of day due to the need to enforce social distancing.

Mary Adler asked how the District's 70 percent service reduction compares to other agencies. Ms. Ross said that BART and Caltrain are both down 90 percent. She said she was not sure about Muni.

Ms. Lacsamana asked how the District determines the number of people allowed on the buses. Ms. Ross said they are adhering to six-foot distancing and operators wear masks. She added that the County says that riders must also wear masks. She said that they will not refuse service to riders not wearing masks, however.

Iris Chan asked if free service will continue. Ms. Ross said that as ridership increases, they would go back to charging fares.



8. CAC MEMBER COMMENTS/REQUESTS

Mr. Johnston said that he was sheltering in place in Wisconsin.

Ms. Chan said that drivers are provided hand sanitizer and asked if it could be provided also to passengers. Ms. Ross said no, that it would be difficult to obtain sanitizer for all passengers.

Ms. Adler said she was working remotely and had not been riding the bus. She said that more people continuing to work remotely even after shelter in place restrictions are relaxed may impact ridership.

Ms. Lacsamana said that her employer may extend remote work and projected 30 to 40 percent layoffs, which would impact ridership.

Allie Juarez said she was concerned about the well-being of the drivers. She expressed gratitude that the District was continuing to provide service.

Vice Chair Baker said that he had ridden the bus very little since the shelter in place went into effect in March.

Vice Chair Baker provided highlights of Board actions from the April 1 meeting.

Ms. Lacsamana said she had no report.
