#### Electrification Infrastructure


On February 27, 2015, the Request for Proposals (RFP) for the Design-Build contract was issued to the six pre-qualified teams. 
During March, there was a pre-proposal conference and an event for Disadvantaged Business Enterprises (DBE) interested in the electrification contract. On March 22, 2015, the first amendment to the RFP was issued and there will be additional amendments in the coming weeks. The JPB is scheduled to award the Design-Build contract in fall 2015.


#### Electric Multiple Units (High-Performance Vehicles)


Over the last several months, Caltrain / HSR staff conducted technical workshops and informal meetings with carbuilders to discuss options to modify the design of Caltrain's EMUs to support compatible platforms with HSR trains in the future. The presentation highlights the benefits and challenges of modifying the vehicles. Additional review by Caltrain's Operations staff is still needed and a presentation of their findings will occur in May.

The process to vet different vehicle modifications started in December 2014 and was initiated based on requests from stakeholders for more analysis on compatible platforms with HSR. JPB policy action on the vehicle RFP is expected in summer 2015, after a public dialogue on the compatibility analysis and bike/seats/bathroom discussion is complete. Delaying the vehicle RFP past summer 2015 could impact the schedule for the overall project. Note: Caltrain staff will request a special LPMG meeting on May 28, 2015 to provide a timely update on this topic.













