As we wrap up the fourth year of the Local Policy Maker Group (LPMG) meeting, the CalMod team wanted to take this opportunity to thank you for your participation and contribution.

In 2016, we covered many issues and we benefited from the LPMG member's feedback that provides us with an important local perspective from each city and county along the Peninsula Corridor Electrification Project corridor. We were proud to celebrate several important milestones with LPMG members. On August 15, 2016, there was a contract signing ceremony for Balfour Beatty (electrification infrastructure) and Stadler (high-performance electric trains). We were also happy to host U.S. Transportation Secretary Foxx and thank him for the Administration's support for the project.

Looking ahead to 2017, we expect the LPMG to continue to provide valuable feedback on how the construction work is managed and coordinated with local jurisdictions. The full construction activities are expected to kick-off in spring/summer 2017 and we will be working closely with the Construction Advisory Teams members selected by cities.

In 2017, there will also be several opportunities to weigh-in on the design of the new electric trains. In the past, LPMG members provided useful feedback on the key decisions that influenced capacity (8:1 ratio bikes to seats; 1 bathroom per train) and we hope for more LPMG feedback as we better understand the specific design considerations.

In January 2017, the LPMG membership will vote on the Vice-Chair (a position created in 2016) for the calendar year. A Caltrain Joint Powers Board of Director representative will continue to Chair the LPMG meetings.
